

2011 was a record year for company registrations in Isleworth when compared to any year in history.

A total of 388 companies were formed in Isleworth in 2011. This total is 3.7% higher than in 2010 and compares favourably to the UK figure of a 13.1% growth compared to 400,358 the previous year.






A total of 147 companies were added to the company register for Isleworth in 2011. This number represents growth of 39.3% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)




Net company growth for Isleworth during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 23 companies.




net growth by month


company share by year





director age by year




director age by half year

director age by quarter




