

A total of 121 companies were formed in Iver in 2011. This total is 24.7% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

The second half of 2011 saw a new record in company registrations in Iver when compared to any previous second half year.


The second half of 2011 was a record second half year for company registrations in Iver when compared to any half year in history.

## Quarterly Data (Q4 Oct-Dec 2011)


Q4 2011 saw a new record in company registrations in Iver when compared to any previous Q4.





#### dissolved companies by year




# Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 38 companies were dissolved in Iver. This figure is 46.2% higher than last year, which compares badly to the UK wide change of -7.5%.

#### dissolved companies by half year




A total of 19 companies were dissolved in Iver during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 34 companies were added to the company register for Iver in 2011. This number represents growth of 35.1% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Iver during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 10 companies.


#### net growth by quarter



#### company share by year









#### director age by year





#### director age by half year




#### director age by quarter

#### director gender by year




# Half Year Data (Jul-Dec 2011)
