
The first half of 2011 was a record first half year for company registrations in Keighley when compared to any half year in history.

Q2 2011 saw a new record in company registrations in Keighley when compared to any previous Q2.


Q2 2011 was a record quarter for company registrations in Keighley when compared to any quarter in history.



dissolved companies by half year






A total of 39 companies were dissolved in Keighley during the second quarter of 2011 (Apr 2011 - Jun 2011).

dissolved companies by quarter





net growth by half year




net growth by quarter




company share by half year



director age by half year






director age by quarter

director gender by half year


