




## Half Year Data (Jul-Dec 2011)




#### new companies by half year






A total of 81 companies were dissolved in Kenilworth during the fourth quarter of 2011 (Oct 2011 - Dec 2011).






## Half Year Data (Jul-Dec 2011)





### net growth by quarter






company share by year





#### director age by year





#### director age by half year



## director age by quarter





## director gender by year




# Half Year Data (Jul-Dec 2011)

25.0% of all director appointments in Kenilworth in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


## director gender by half year
