

2011 was a record year for company registrations in Kidderminster when compared to any year in history.

A total of 341 companies were formed in Kidderminster in 2011. This total is 19.2% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Kidderminster when compared to any previous second half year.

In the second half of 2011 a total of 161 companies were formed in Kidderminster. This figure is 15.0% higher than last year, which compares well to the UK wide figure of 14.0%.




A total of 73 companies were registered in Kidderminster during the fourth quarter of 2011 (Oct 2011 - Dec 2011).



dissolved companies by year




Half Year Data (Jul-Dec 2011)




A total of 48 companies were dissolved in Kidderminster during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 155 companies were added to the company register for Kidderminster in 2011. This number represents growth of 54.2% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year








company share by year







director age by year








director age by quarter





director gender by year




Half Year Data (Jul-Dec 2011)

26.8% of all director appointments in Kidderminster in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


director gender by half year
