The highest total for a first half year in Kingston Upon Thames occurred in 2007 when a total of 1,041 were formed.


RECORD YEAR

#### dissolved companies by half year




# Quarterly Data (Q2 Apr-Jun 2011)



#### net growth by half year













company share by month





## director age by half year






The percentage of directors over the age of 65 was 5.1% compared to the UK figure of 4.3%.






The record first half year for female directors in Kingston Upon Thames was 1861 when 40.0% of all directors were female.
