
Half Year Data (Jan-Jun 2012)

In the first half of 2012 a total of 493 companies were formed in Kingston Upon Thames. This figure is 50.3% higher than last year, which compares well to the UK wide figure of 10.7%.

The highest total for a first half year in Kingston Upon Thames occurred in 2007 when a total of 1,041 were formed.

A total of 255 companies were registered in Kingston Upon Thames during the second quarter of 2012 (Apr 2012 - Jun 2012).

This figure is an increase of 50.9% versus the same period last year (Q2 2011). This figure compares well to the UK as a whole, which saw an increase of 8.3% against the same period last year.



dissolved companies by half year




A total of 193 companies were dissolved in Kingston Upon Thames during the second quarter of 2012 (Apr 2012 - Jun 2012).








net growth by month


company share by half year





director age by half year



The percentage of directors under the age of 25 was 9.2% compared to the UK figure of 5.2%.


The percentage of directors over the age of 65 was 4.1% compared to the UK figure of 3.3%.

director gender by half year


