
The first half of 2011 was a record first half year for company registrations in Kingswinford when compared to any half year in history.

In the first half of 2011 a total of 115 companies were formed in Kingswinford. This figure is 64.3% higher than last year, which compares well to the UK wide figure of 12.3%.

#### new companies by half year





A total of 43 companies were registered in Kingswinford during the second quarter of 2011 (Apr 2011 - Jun 2011).





#### dissolved companies by half year





A total of 15 companies were dissolved in Kingswinford during the second quarter of 2011 (Apr 2011 - Jun 2011).





#### net growth by half year













#### director age by half year






#### director age by quarter
