

A total of 269 companies were formed in Knutsford in 2011. This total is 20.1% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

new companies by half year




Quarterly Data (Q4 Oct-Dec 2011)


new companies by quarter




The second half of 2011 saw a new record in company closures in Knutsford when compared to any previous second half year.

dissolved companies by half year




Q4 2011 saw a new record in company closures in Knutsford when compared to any previous Q4.


A total of 113 companies were added to the company register for Knutsford in 2011. This number represents growth of 50.4% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Knutsford during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 13 companies.


net growth by quarter

net growth by month






company share by half year





director age by year





director age by half year



director gender by year




Half Year Data (Jul-Dec 2011)

director gender by half year


