

2011 was a record year for company registrations in Lanark when compared to any year in history.

A total of 145 companies were formed in Lanark in 2011. This total is 7.4% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.

#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 61 companies were formed in Lanark. This figure is 6.2% lower than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Lanark occurred in 2010 when a total of 65 were formed.




A total of 24 companies were registered in Lanark during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 55 companies were dissolved in Lanark. This figure is 3.5% lower than last year, which compares badly to the UK wide change of -7.5%.

#### dissolved companies by half year




A total of 27 companies were dissolved in Lanark during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


#### dissolved companies by quarter


A total of 58 companies were added to the company register for Lanark in 2011. This number represents growth of 43.0% which compares favourably to the UK figure of 34.6%.




#### Half Year Data (Jul-Dec 2011)




Net company growth for Lanark during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was -3 companies.








#### company share by half year





#### director age by year





#### director age by half year




#### director age by quarter

#### director gender by year




## Half Year Data (Jul-Dec 2011)
