




# Quarterly Data (Q2 Apr-Jun 2011)

A total of 71 companies were registered in Lancaster during the second quarter of 2011 (Apr 2011 - Jun 2011).





#### dissolved companies by half year




# Quarterly Data (Q2 Apr-Jun 2011)

A total of 44 companies were dissolved in Lancaster during the second quarter of 2011 (Apr 2011 - Jun 2011).



#### dissolved companies by quarter















#### director age by half year



The percentage of directors under the age of 25 was 4.8% compared to the UK figure of 3.4%.


The percentage of directors over the age of 65 was 7.5% compared to the UK figure of 4.3%.

#### director gender by half year


