
Q1 2011 was a record quarter for company registrations in Leicester when compared to any quarter in history.

A total of 854 companies were registered in Leicester during the first quarter of 2011 (Jan 2011 - Mar 2011).

This figure is an increase of 11.5% versus the same period last year (Q1 2010). This figure compares equally to the UK as a whole, which saw an increase of 10.7% against the same period last year.


Q1 2011 saw a new record in company closures in Leicester when compared to any previous Q1.


#### dissolved companies by quarter

#### dissolved companies by month












