


2011 was a record year for company registrations in Leigh when compared to any year in history.

A total of 187 companies were formed in Leigh in 2011. This total is 9.4% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.


Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 92 companies were formed in Leigh. This figure is 16.5% higher than last year, which compares well to the UK wide figure of 14.0%.

new companies by half year




A total of 46 companies were registered in Leigh during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


new companies by quarter



dissolved companies by year




Half Year Data (Jul-Dec 2011)




A total of 20 companies were dissolved in Leigh during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 90 companies were added to the company register for Leigh in 2011. This number represents growth of 52.6% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Leigh during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 26 companies.


net growth by quarter






company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)
