




## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 154 companies were formed in Leighton Buzzard. This figure is 3.8% lower than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Leighton Buzzard occurred in 2010 when a total of 160 were formed.




#### new companies by half year








## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 110 companies were dissolved in Leighton Buzzard. This figure is 6.8% lower than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Leighton Buzzard occurred in 2009 when a total of 144 were closed.


#### dissolved companies by half year






## Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Leighton Buzzard during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 20 companies.



#### net growth by quarter






#### company share by year







#### director age by year





#### director age by quarter





#### director gender by year




## Half Year Data (Jul-Dec 2011)

29.8% of all director appointments in Leighton Buzzard in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


#### director gender by half year
