
The first half of 2011 saw a new record in company registrations in Leyland when compared to any previous first half year.

The first half of 2011 was a record first half year for company registrations in Leyland when compared to any half year in history.

In the first half of 2011 a total of 120 companies were formed in Leyland. This figure is 21.2% higher than last year, which compares well to the UK wide figure of 12.3%.

The highest total for a first half year in Leyland occurred in 2011 when a total of 120 were formed.


## Quarterly Data (Q2 Apr-Jun 2011)





#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2011)



#### dissolved companies by quarter







#### net growth by half year



Net company growth for Leyland during the second quarter of 2011 (Apr 2011 - Jun 2011) was 14 companies.






company share by half year





#### director age by half year





## Quarterly Data (Q2 Apr-Jun 2011)

The average age of a director in the second quarter of 2011 was 49.1.

The percentage of directors under the age of 25 was 2.9% compared to the UK figure of 3.4%.

The percentage of directors over the age of 65 was 10.3% compared to the UK figure of 4.3%.





The record first half year for female directors in Leyland was 1861 when 40.0% of all directors were female.

33.3% of all director appointments in Leyland in the first half of 2011 were female. This compares to a UK average of 25.7% for the same period.

#### director gender by half year




## Quarterly Data (Q2 Apr-Jun 2011)

The record second quarter for female directors in Leyland was in 1866 when 66.7% of all directors were female.

36.4% of all director appointments in Leyland in the second quarter of 2011 were female. This compares to a UK average of 26.1% for the same period.
