

2011 was a record year for company registrations in Leyland when compared to any year in history.

A total of 206 companies were formed in Leyland in 2011. This total is 15.1% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 86 companies were formed in Leyland. This figure is 7.5% higher than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Leyland occurred in 2009 when a total of 112 were formed.

#### new companies by half year




A total of 40 companies were registered in Leyland during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

#### dissolved companies by half year




A total of 44 companies were dissolved in Leyland during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 50 companies were added to the company register for Leyland in 2011. This number represents growth of 27.9% which compares unfavourably to the UK figure of 34.6%.

#### net growth by year






Net company growth for Leyland during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was -4 companies.








#### company share by half year





#### director age by year





#### director age by half year




The average age of a director in the fourth quarter of 2011 was 44.7.

#### director gender by year




# Half Year Data (Jul-Dec 2011)
