




A total of 28,033 companies were registered in London during the first quarter of 2011 (Jan 2011 - Mar 2011).


new companies by quarter




dissolved companies by quarter

dissolved companies by month













The percentage of directors over the age of 65 was 3.5% compared to the UK figure of 4.3%.


director age by quarter
