



A total of 140 companies were registered in Loughborough during the second quarter of 2012 (Apr 2012 - Jun 2012).







A total of 126 companies were dissolved in Loughborough during the second quarter of 2012 (Apr 2012 - Jun 2012).







net growth by quarter






company share by half year





director age by half year



The percentage of directors over the age of 65 was 1.9% compared to the UK figure of 3.3%.




director age by quarter

director gender by half year


