


Half Year Data (Jul-Dec 2011)




A total of 61 companies were registered in Lytham St Annes during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)




A total of 47 companies were dissolved in Lytham St Annes during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 86 companies were added to the company register for Lytham St Annes in 2011. This number represents growth of 42.2% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year





net growth by month








company share by half year





director age by year





director age by half year



director gender by year




Half Year Data (Jul-Dec 2011)

director gender by half year


