The first half of 2011 saw a new record in company registrations in Macclesfield when compared to any previous first half year.


The first half of 2011 was a record first half year for company registrations in Macclesfield when compared to any half year in history.

In the first half of 2011 a total of 414 companies were formed in Macclesfield. This figure is 41.3% higher than last year, which compares well to the UK wide figure of 12.3%.

The highest total for a first half year in Macclesfield occurred in 2011 when a total of 414 were formed.

new companies by half year




Quarterly Data (Q2 Apr-Jun 2011)





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2011)










company share by half year





director age by half year





The percentage of directors over the age of 65 was 8.7% compared to the UK figure of 4.3%.


director age by quarter

director gender by half year




Quarterly Data (Q2 Apr-Jun 2011)
