




Q1 2011 saw a new record in company closures in Maidenhead when compared to any previous Q1.




Net company growth for Maidenhead during the first quarter of 2011 (Jan 2011 - Mar 2011) was 52 companies.







The percentage of directors over the age of 65 was 7.3% compared to the UK figure of 4.3%.


director age by quarter
