


The second half of 2011 saw a new record in company registrations in Maidenhead when compared to any previous second half year.

new companies by half year




A total of 148 companies were registered in Maidenhead during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 134 companies were dissolved in Maidenhead during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


dissolved companies by quarter


A total of 181 companies were added to the company register for Maidenhead in 2011. This number represents growth of 27.0% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Maidenhead during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 14 companies.



net growth by month



company share by year




company share by half year





director age by year





director age by half year



director gender by year




Half Year Data (Jul-Dec 2011)

director gender by half year






The record fourth quarter for female directors in Maidenhead was in 1977 when 31.1% of all directors were female.
