




new companies by half year




Half Year Data (Jul-Dec 2011)




Q4 2011 saw a new record in company closures in Maidstone when compared to any previous Q4.




A total of 259 companies were added to the company register for Maidstone in 2011. This number represents growth of 30.7% which compares unfavourably to the UK figure of 34.6%.

net growth by year










company share by year




company share by half year





director age by year






