

#### new companies by half year




#### Quarterly Data (Q2 Apr-Jun 2012)

A total of 44 companies were registered in Malvern during the second quarter of 2012 (Apr 2012 - Jun 2012).





#### dissolved companies by half year




#### Quarterly Data (Q2 Apr-Jun 2012)

A total of 34 companies were dissolved in Malvern during the second quarter of 2012 (Apr 2012 - Jun 2012).



#### net growth by half year













### director age by half year




