

2011 was a record year for company registrations in Market Harborough when compared to any year in history.

A total of 209 companies were formed in Market Harborough in 2011. This total is 2.0% higher than in 2010 and compares favourably to the UK figure of a 13.1% growth compared to 400,358 the previous year.




Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 93 companies were formed in Market Harborough. This figure is 7.0% lower than last year, which compares badly to the UK wide figure of 14.0%.




new companies by half year



dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




Q4 2011 saw a new record in company closures in Market Harborough when compared to any previous Q4.




A total of 66 companies were added to the company register for Market Harborough in 2011. This number represents growth of 32.2% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year



net growth by quarter






company share by year





director age by year




director age by half year

director age by quarter





director gender by year




Half Year Data (Jul-Dec 2011)
