
A total of 161 companies were registered in Middlesbrough during the second quarter of 2012 (Apr 2012 - Jun 2012).












company share by half year





director age by half year










The record first half year for female directors in Middlesbrough was 1861 when 40.0% of all directors were female.

director gender by half year


