

A total of 2,414 companies were formed in Milton Keynes in 2011. This total is 21.6% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Milton Keynes when compared to any previous second half year.


Q4 2011 saw a new record in company registrations in Milton Keynes when compared to any previous Q4.


new companies by quarter



dissolved companies by year




Half Year Data (Jul-Dec 2011)


dissolved companies by half year





net growth by year





net growth by half year




Net company growth for Milton Keynes during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 168 companies.


net growth by quarter

net growth by month






company share by year




company share by half year





director age by year





director age by half year



director age by quarter





director gender by year




Half Year Data (Jul-Dec 2011)

27.2% of all director appointments in Milton Keynes in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


director gender by half year
