
The first half of 2012 was a record first half year for company registrations in Mitcham when compared to any half year in history.

In the first half of 2012 a total of 337 companies were formed in Mitcham. This figure is 3.7% higher than last year, which compares badly to the UK wide figure of 10.7%.


Q2 2012 saw a new record in company registrations in Mitcham when compared to any previous Q2.

A total of 168 companies were registered in Mitcham during the second quarter of 2012 (Apr 2012 - Jun 2012).

This figure is an increase of 11.3% versus the same period last year (Q2 2011). This figure compares equally to the UK as a whole, which saw an increase of 8.3% against the same period last year.



#### new companies by month





#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2012)

A total of 90 companies were dissolved in Mitcham during the second quarter of 2012 (Apr 2012 - Jun 2012).

This figure is an increase of 42.9% versus the same period last year (Q2 2011). This figure compares poorly to the UK as a whole, which saw an increase of 12.5% against the same period last year.


The first half of 2012 saw a new record in net growth in Mitcham when compared to any previous first half year.

#### net growth by half year




## Quarterly Data (Q2 Apr-Jun 2012)

This represents a decrease of 11.4% on the same period last year.











#### director age by half year




## Quarterly Data (Q2 Apr-Jun 2012)

The percentage of directors over the age of 65 was 2.6% compared to the UK figure of 3.3%.


#### director age by quarter



The record first half year for female directors in Mitcham was 1861 when 40.0% of all directors were female.

25.9% of all director appointments in Mitcham in the first half of 2012 were female. This compares to a UK average of 23.4% for the same period.

# Quarterly Data (Q2 Apr-Jun 2012)

The record second quarter for female directors in Mitcham was in 1866 when 66.7% of all directors were female.

23.6% of all director appointments in Mitcham in the second quarter of 2012 were female. This compares to a UK average of 21.3% for the same period.
