

A total of 320 companies were formed in Motherwell in 2011. This total is 56.1% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

Q4 2011 saw a new record in company registrations in Motherwell when compared to any previous Q4.


Q4 2011 was a record quarter for company registrations in Motherwell when compared to any quarter in history.



#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

## dissolved companies by half year




A total of 39 companies were dissolved in Motherwell during the fourth quarter of 2011 (Oct 2011 - Dec 2011).



2011 was a record year for net growth in Motherwell when compared to any year in history.


A total of 197 companies were added to the company register for Motherwell in 2011. This number represents growth of 96.1% which compares favourably to the UK figure of 34.6%.




Q4 2011 was a record quarter for net growth in Motherwell when compared to any quarter in history.


#### net growth by quarter

#### net growth by month





#### company share by year






#### company share by half year





#### director age by year





#### director age by half year




The average age of a director in the fourth quarter of 2011 was 45.6.

#### director gender by year




## Half Year Data (Jul-Dec 2011)
