
The first half of 2012 was a record first half year for company registrations in Motherwell when compared to any half year in history.


Q2 2012 saw a new record in company registrations in Motherwell when compared to any previous Q2.

#### new companies by quarter






The first half of 2012 saw a new record in company closures in Motherwell when compared to any previous first half year.

#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2012)


#### dissolved companies by quarter




Q2 2012 was a record quarter for net growth in Motherwell when compared to any quarter in history.

#### net growth by quarter







## company share by half year







#### director age by half year




# Quarterly Data (Q2 Apr-Jun 2012)

The percentage of directors over the age of 65 was 5.8% compared to the UK figure of 3.3%.


#### director age by quarter
