
The first half of 2012 saw a new record in company registrations in Nelson when compared to any previous first half year.

In the first half of 2012 a total of 117 companies were formed in Nelson. This figure is 27.2% higher than last year, which compares well to the UK wide figure of 10.7%.

The highest total for a first half year in Nelson occurred in 2012 when a total of 117 were formed.

new companies by half year





A total of 43 companies were registered in Nelson during the second quarter of 2012 (Apr 2012 - Jun 2012).





dissolved companies by half year








The first half of 2012 saw a new record in net growth in Nelson when compared to any previous first half year.

net growth by half year















director age by half year






director age by quarter

director gender by half year


