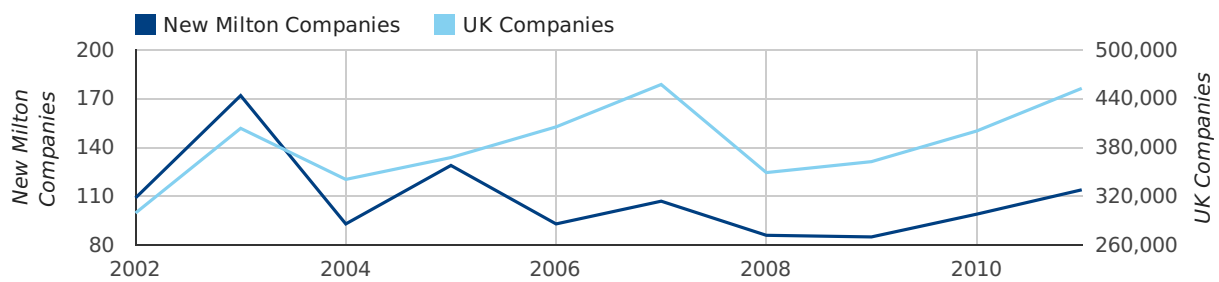

new companies by year



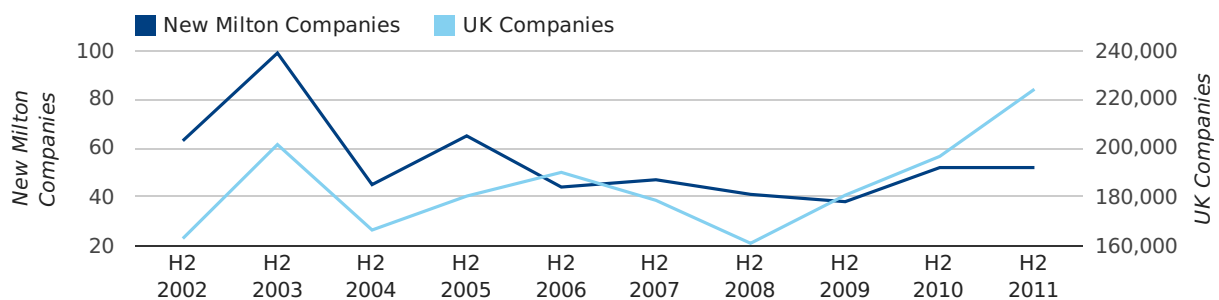
Half Year Data (Jul-Dec 2011)

new companies by half year



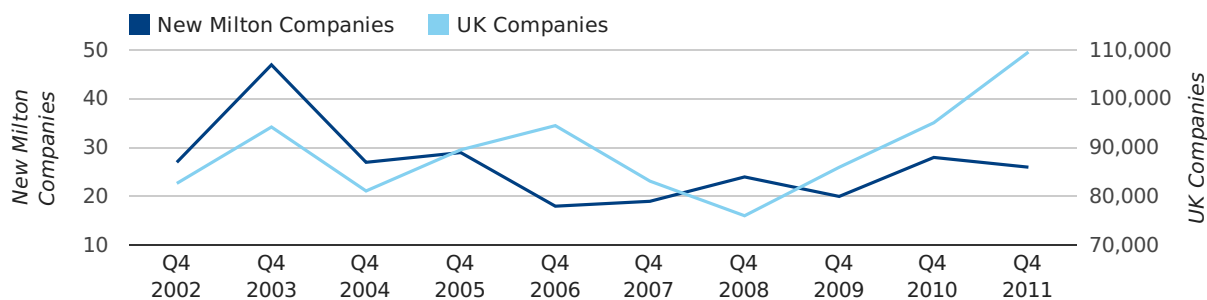
Quarterly Data (Q4 Oct-Dec 2011)

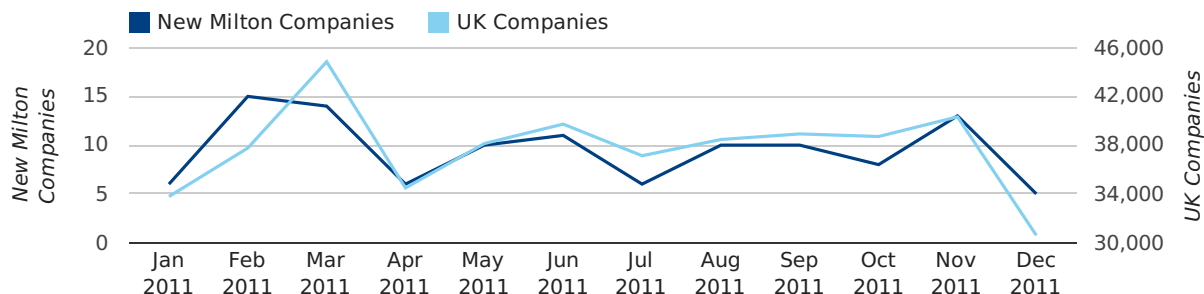

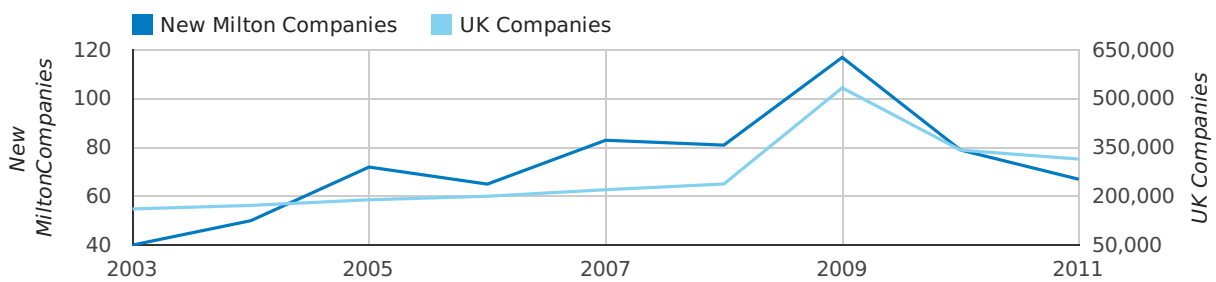

dissolved companies by year



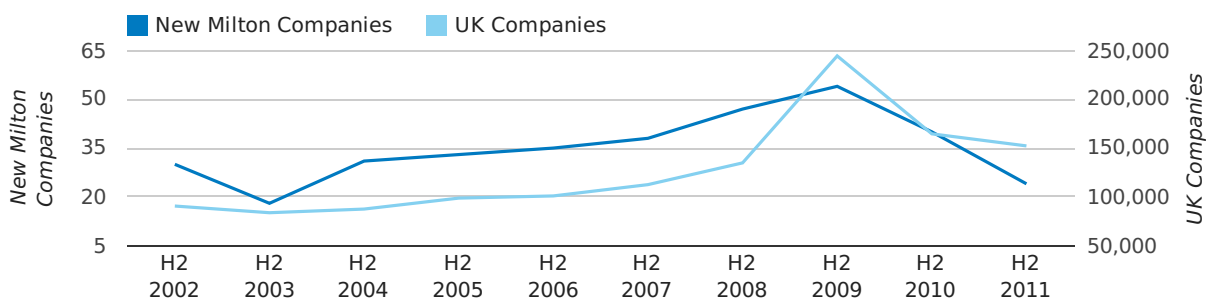
Half Year Data (Jul-Dec 2011)

dissolved companies by half year



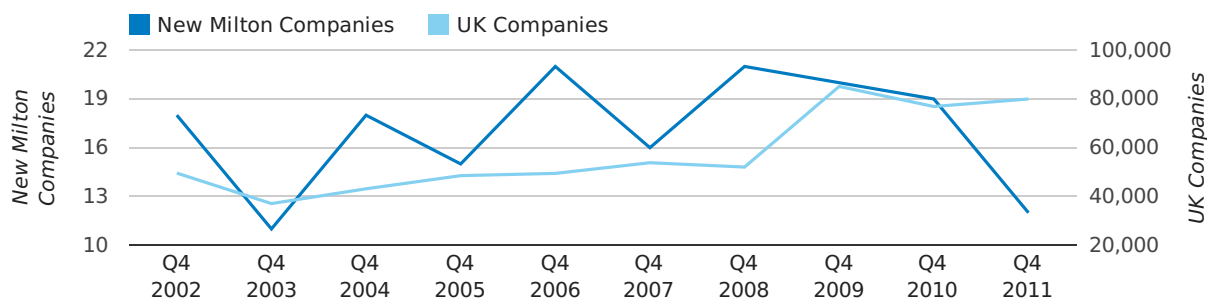
Quarterly Data (Q4 Oct-Dec 2011)

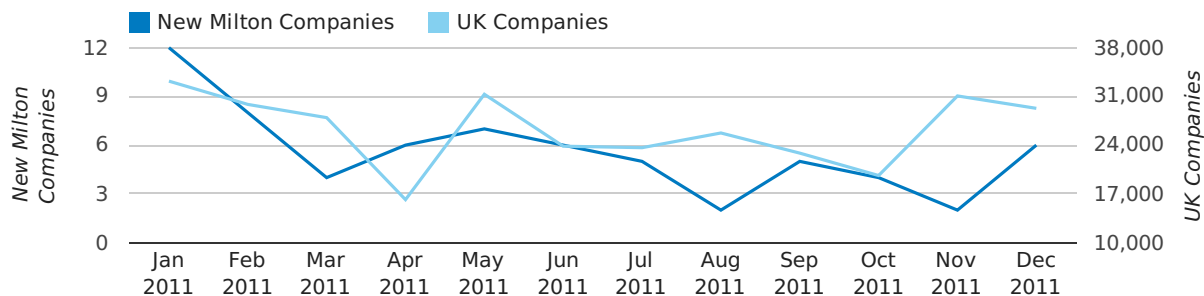

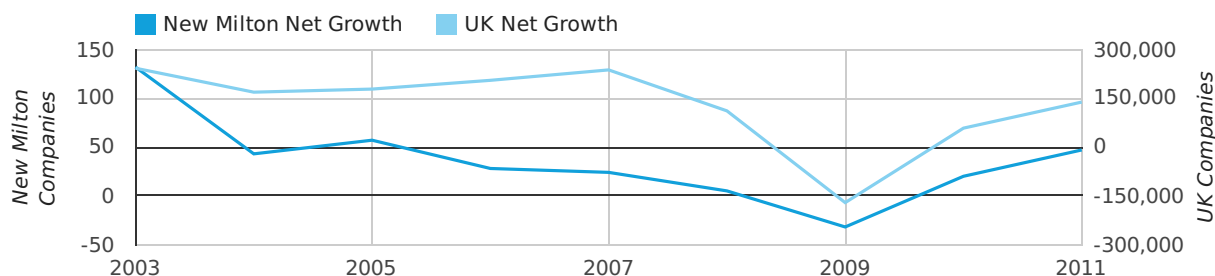
A total of 47 companies were added to the company register for New Milton in 2011. This number represents growth of 47.5% which compares favourably to the UK figure of 34.6%.

net growth by year

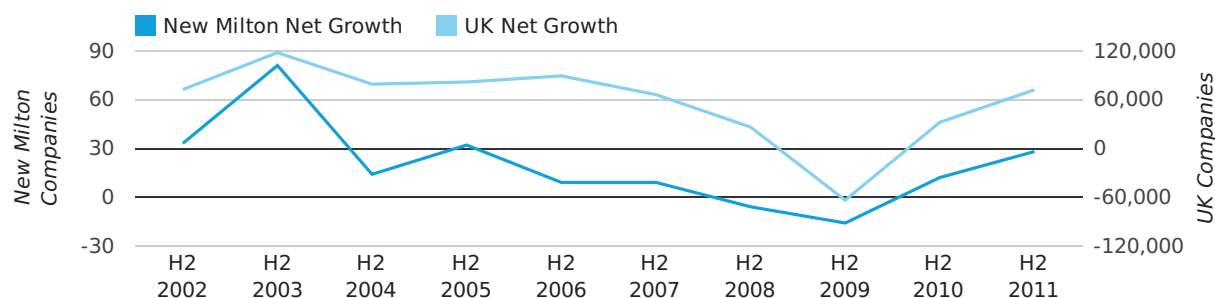


Half Year Data (Jul-Dec 2011)

net growth by half year



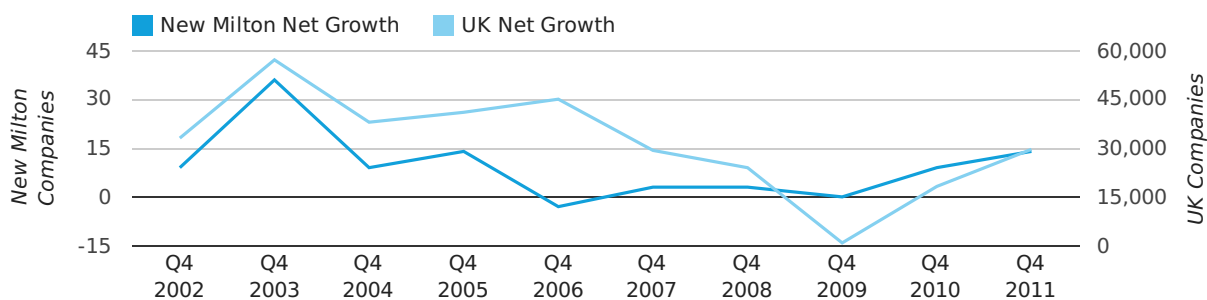

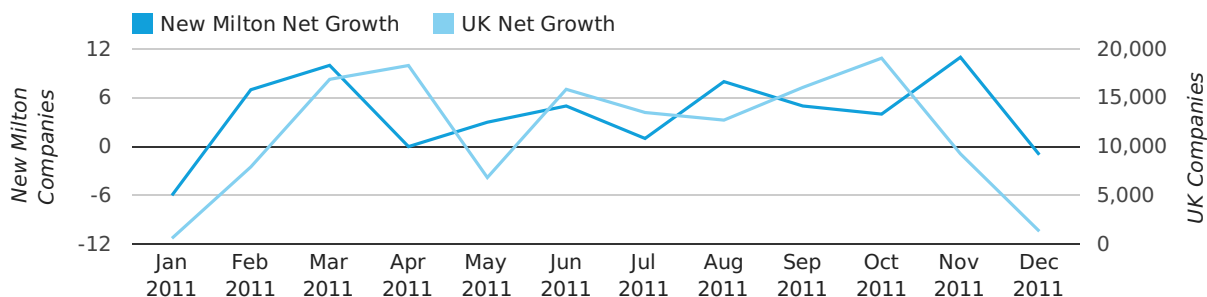

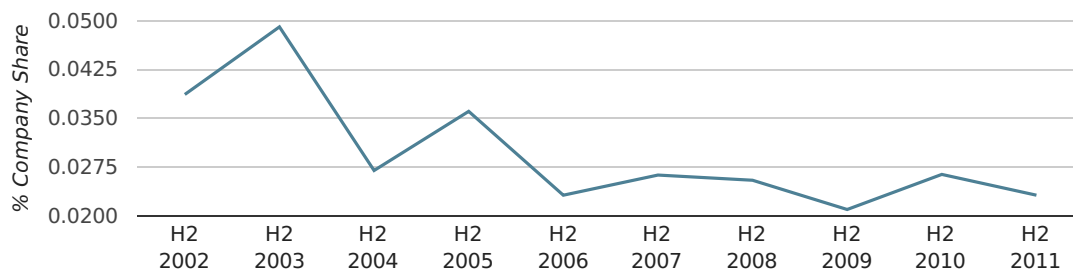

company share by half year

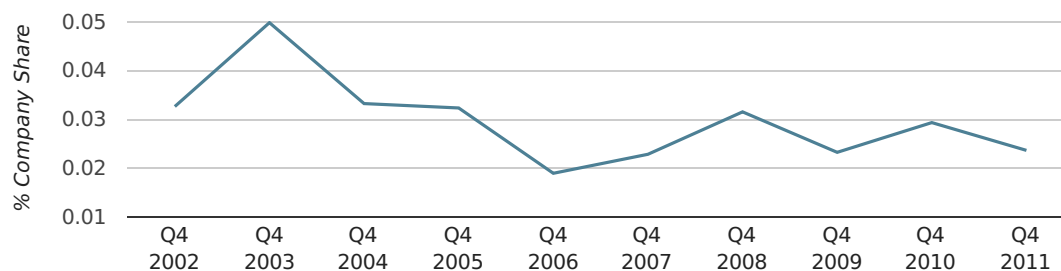

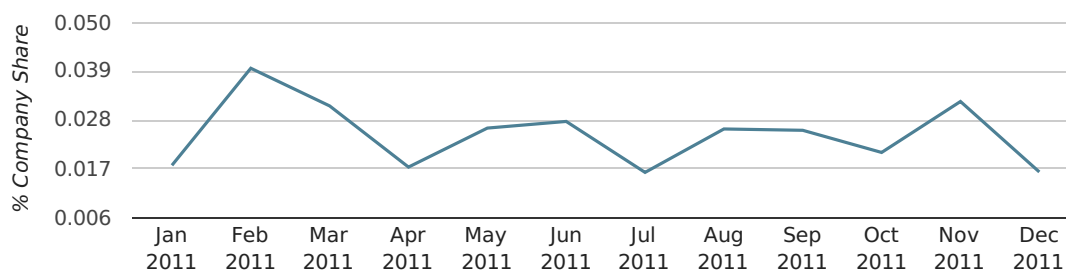

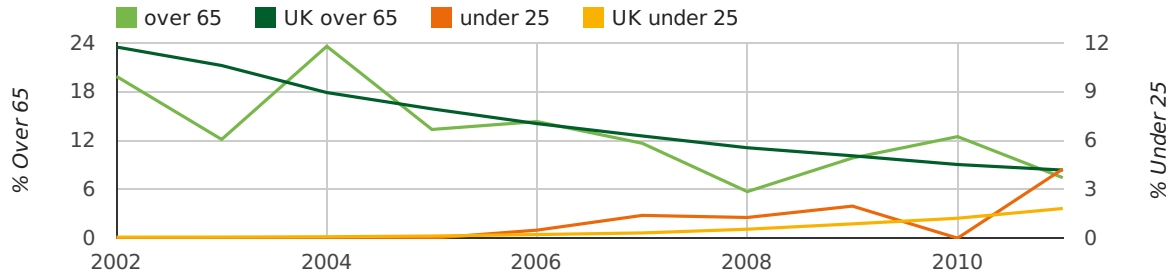

director age by year



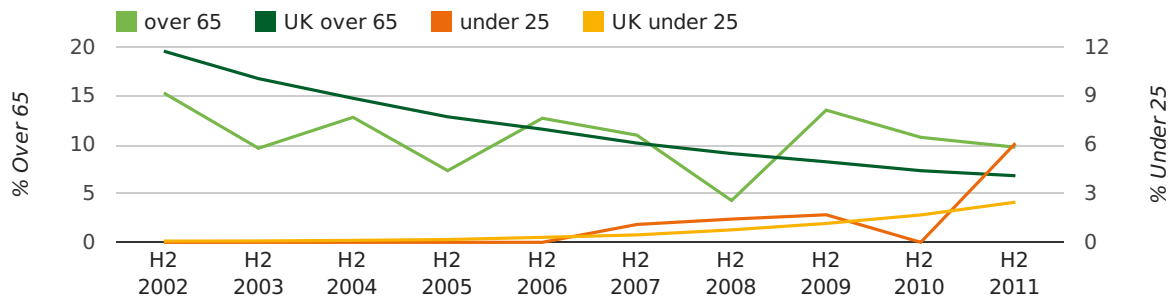

director age by half year



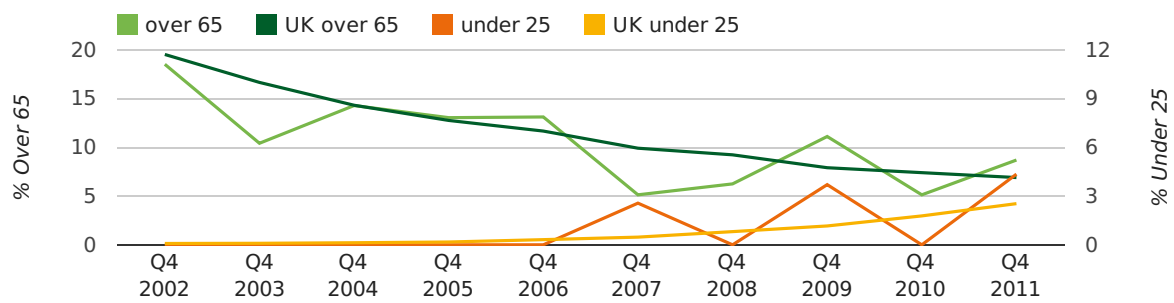

director age by quarter

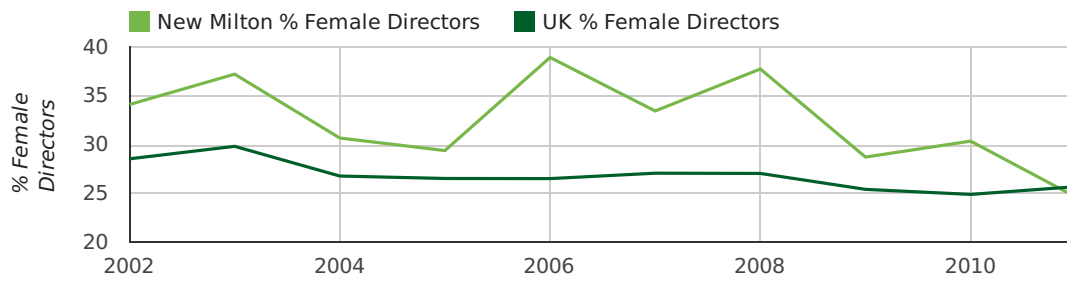

director gender by year

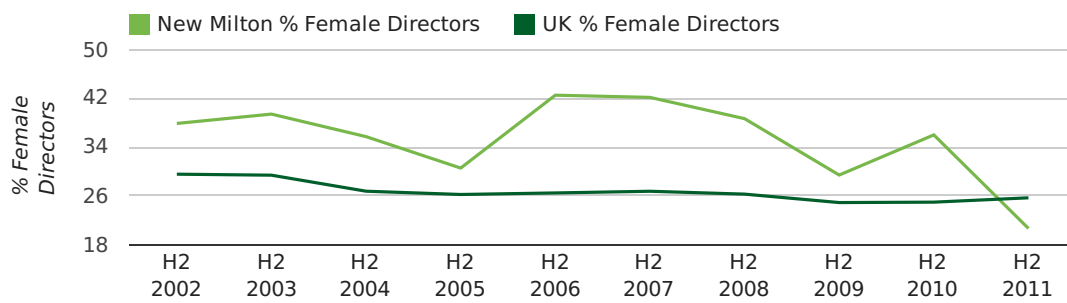


Half Year Data (Jul-Dec 2011)

director gender by half year

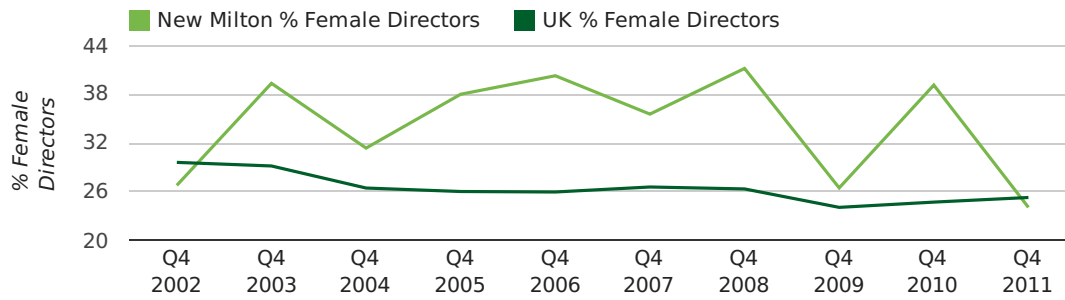


Quarterly Data (Q4 Oct-Dec 2011)
