

#### new companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 161 companies were formed in Newark. This figure is 1.9% higher than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Newark occurred in 2003 when a total of 194 were formed.

#### new companies by half year




A total of 75 companies were registered in Newark during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

#### dissolved companies by half year




Q4 2011 saw a new record in company closures in Newark when compared to any previous Q4.


#### dissolved companies by quarter


A total of 81 companies were added to the company register for Newark in 2011. This number represents growth of 24.9% which compares unfavourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)




Net company growth for Newark during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 17 companies.








#### company share by half year





#### director age by year





#### director age by half year



#### director gender by year




# Half Year Data (Jul-Dec 2011)
