The first half of 2011 saw a new record in company registrations in Newbury when compared to any previous first half year.


The first half of 2011 was a record first half year for company registrations in Newbury when compared to any half year in history.

In the first half of 2011 a total of 324 companies were formed in Newbury. This figure is 14.5% higher than last year, which compares well to the UK wide figure of 12.3%.

The highest total for a first half year in Newbury occurred in 2011 when a total of 324 were formed.

Q2 2011 saw a new record in company registrations in Newbury when compared to any previous Q2.


Q2 2011 was a record quarter for company registrations in Newbury when compared to any quarter in history.


new companies by quarter



dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2011)





net growth by half year









company share by half year







director age by half year




