

A total of 588 companies were formed in Newbury in 2011. This total is 8.3% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.


Q4 2011 saw a new record in company registrations in Newbury when compared to any previous Q4.



November 2011 saw a new record in company registrations in Newbury when compared to any previous November.





dissolved companies by year




Half Year Data (Jul-Dec 2011)


dissolved companies by half year


A total of 206 companies were added to the company register for Newbury in 2011. This number represents growth of 37.9% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Newbury during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 37 companies.

net growth by quarter






company share by year







director age by year





director age by half year




director age by quarter
