


Half Year Data (Jul-Dec 2011)

new companies by half year




A total of 94 companies were registered in Newcastle during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 66 companies were dissolved in Newcastle during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 76 companies were added to the company register for Newcastle in 2011. This number represents growth of 21.9% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Newcastle during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 28 companies.








company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)
