
The first half of 2012 saw a new record in company registrations in Newcastle Upon Tyne when compared to any previous first half year.

The first half of 2012 was a record first half year for company registrations in Newcastle Upon Tyne when compared to any half year in history.

In the first half of 2012 a total of 1,116 companies were formed in Newcastle Upon Tyne. This figure is 11.7% higher than last year, which compares well to the UK wide figure of 10.7%.

The highest total for a first half year in Newcastle Upon Tyne occurred in 2012 when a total of 1,116 were formed.


Quarterly Data (Q2 Apr-Jun 2012)

A total of 533 companies were registered in Newcastle Upon Tyne during the second quarter of 2012 (Apr 2012 - Jun 2012).

This figure is an increase of 8.8% versus the same period last year (Q2 2011). This figure compares equally to the UK as a whole, which saw an increase of 8.3% against the same period last year.








Quarterly Data (Q2 Apr-Jun 2012)



net growth by half year



Net company growth for Newcastle Upon Tyne during the second quarter of 2012 (Apr 2012 - Jun 2012) was 176 companies.






company share by half year





director age by half year





The percentage of directors over the age of 65 was 4.1% compared to the UK figure of 3.3%.


director age by quarter

The record second quarter for female directors in Newcastle Upon Tyne was in 1866 when 66.7% of all directors were female.

17.4% of all director appointments in Newcastle Upon Tyne in the second quarter of 2012 were female. This compares to a UK average of 21.3% for the same period.
