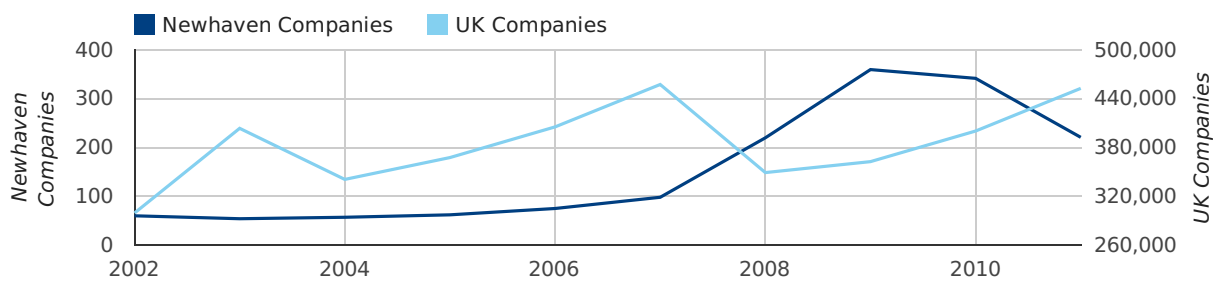

### Annual Data (2011)

A total of 221 companies were formed in Newhaven in 2011. This total is 35.4% lower than in 2010 and compares favourably to the UK figure of a 13.1% growth compared to 400,358 the previous year.

### new companies by year



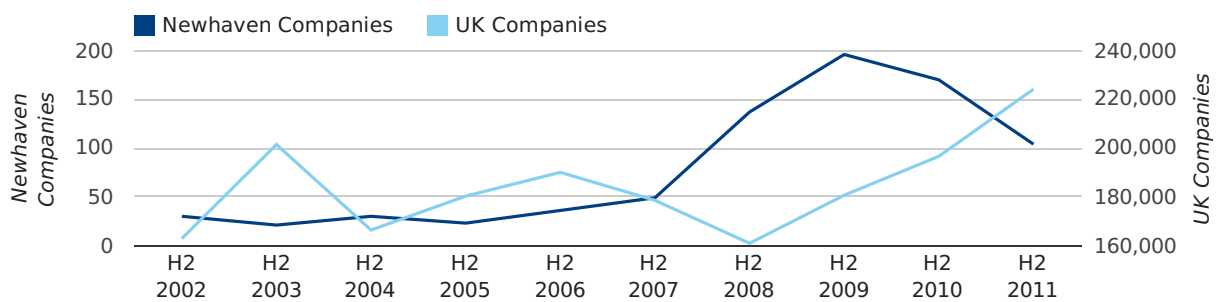
### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 104 companies were formed in Newhaven. This figure is 38.8% lower than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Newhaven occurred in 2009 when a total of 196 were formed.

### new companies by half year



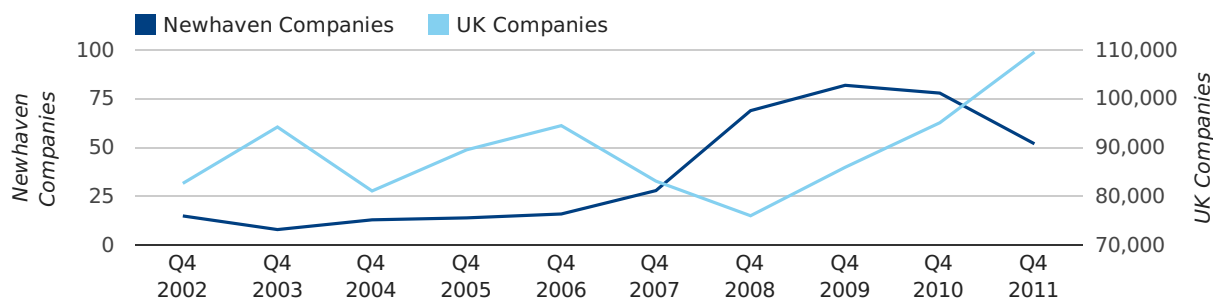
## Quarterly Data (Q4 Oct-Dec 2011)

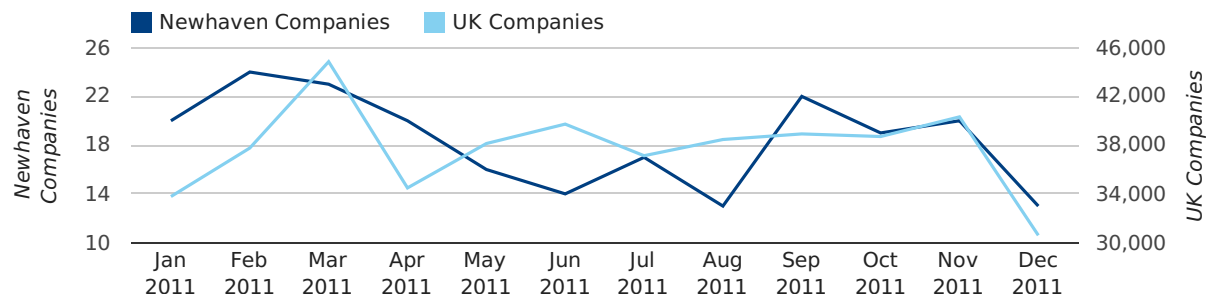

2011 was a record year for company closures in Newhaven when compared to any year in history.

A total of 288 companies were dissolved in Newhaven in 2011. This total is 22.6% higher than in 2010 and compares favourably to the UK figure of 8.1% decrease compared to the previous year.

## Half Year Data (Jul-Dec 2011)

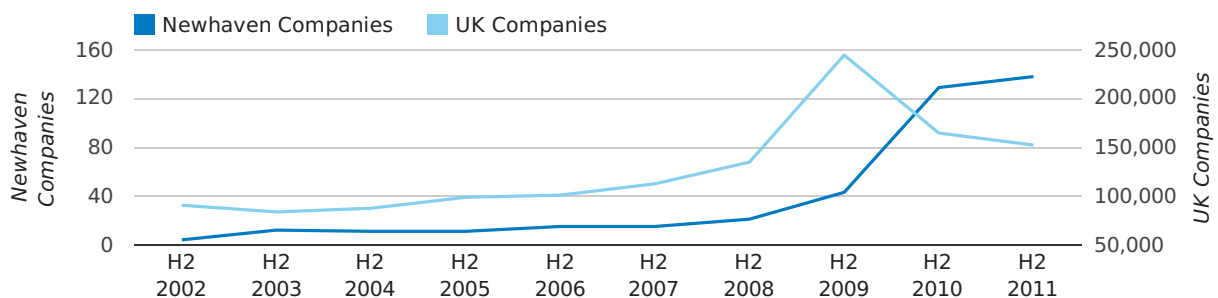
The second half of 2011 saw a new record in company closures in Newhaven when compared to any previous second half year.

In the second half of 2011 a total of 138 companies were dissolved in Newhaven. This figure is 7.0% higher than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Newhaven occurred in 2011 when a total of 138 were closed.

## Quarterly Data (Q4 Oct-Dec 2011)

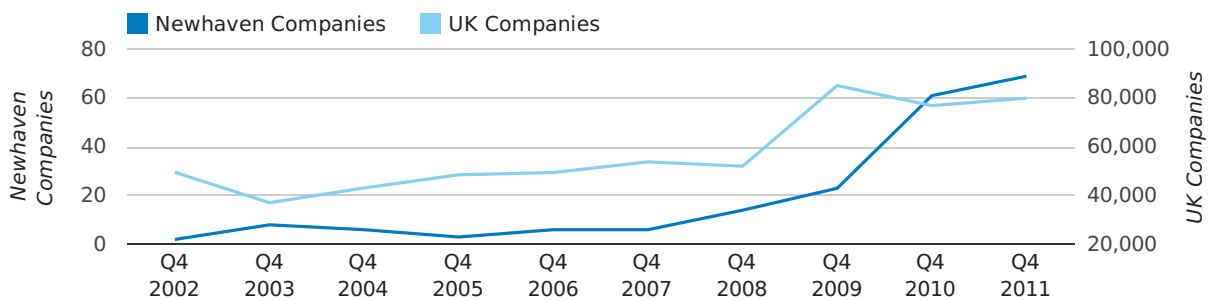
Q4 2011 saw a new record in company closures in Newhaven when compared to any previous Q4.

A total of 69 companies were dissolved in Newhaven during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

This figure is an increase of 13.1% versus the same period last year (Q4 2010). This figure compares poorly to the UK as a whole, which saw an increase of 4.0% against the same period last year.

### dissolved companies by quarter

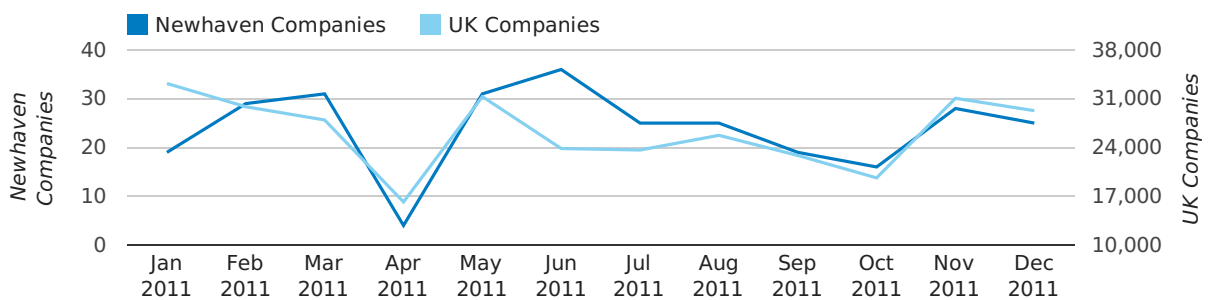

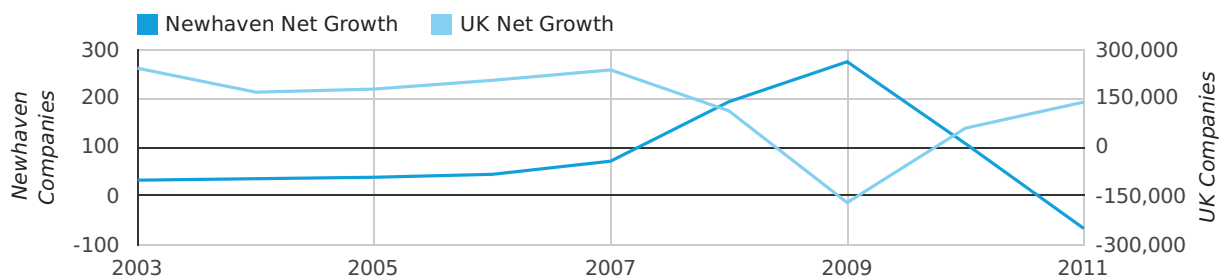
A total of -67 companies were removed to the company register for Newhaven in 2011. This number represents decline of 19.6% which compares unfavourably to the UK figure of 34.6%.

### net growth by year

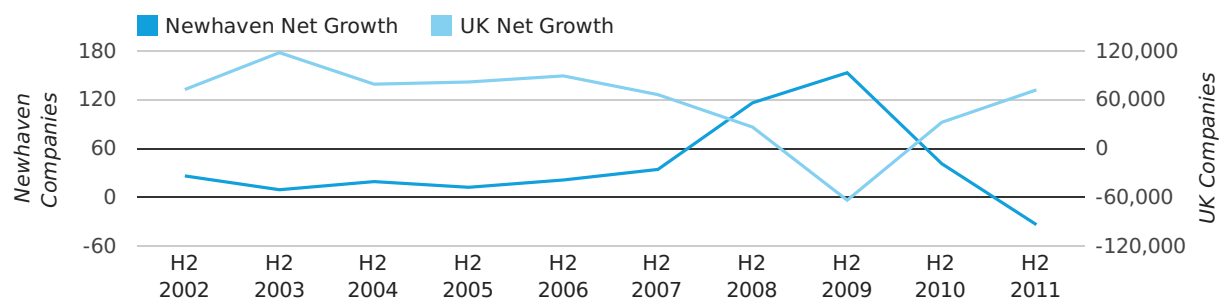


### Half Year Data (Jul-Dec 2011)

### net growth by half year



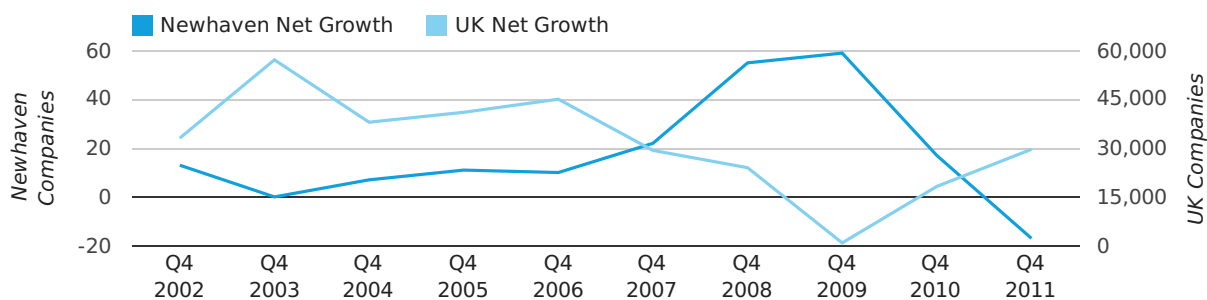
## Quarterly Data (Q4 Oct-Dec 2011)

This represents a decrease of 200.0% on the same period last year.

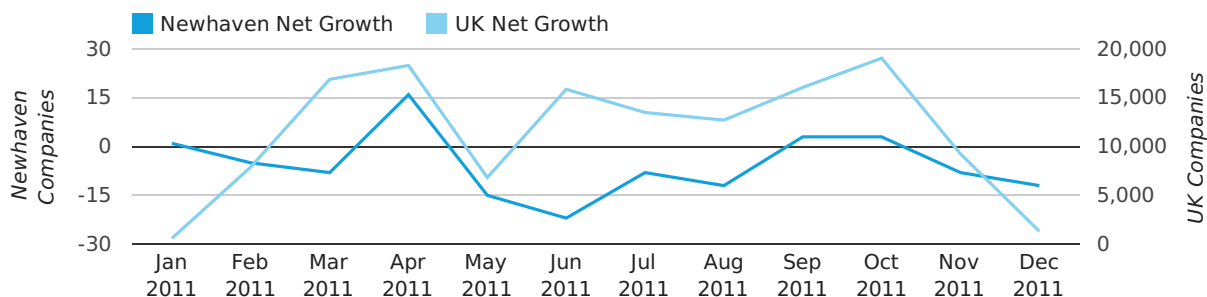

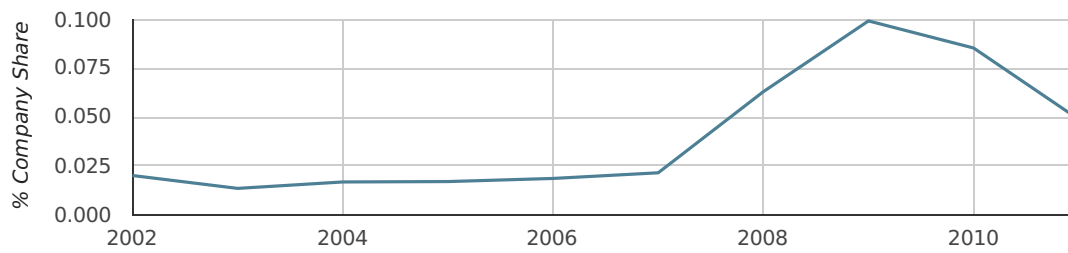

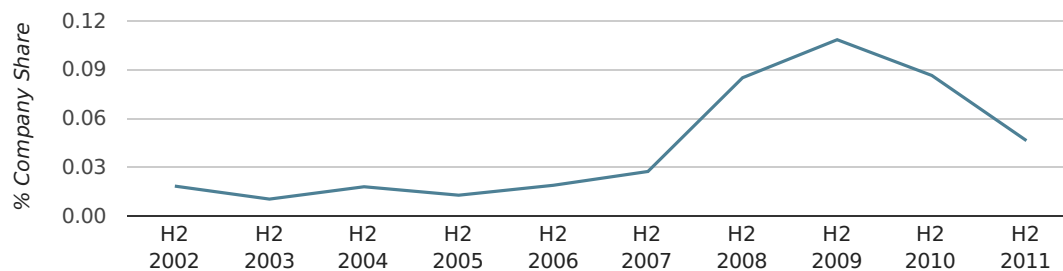

#### company share by half year

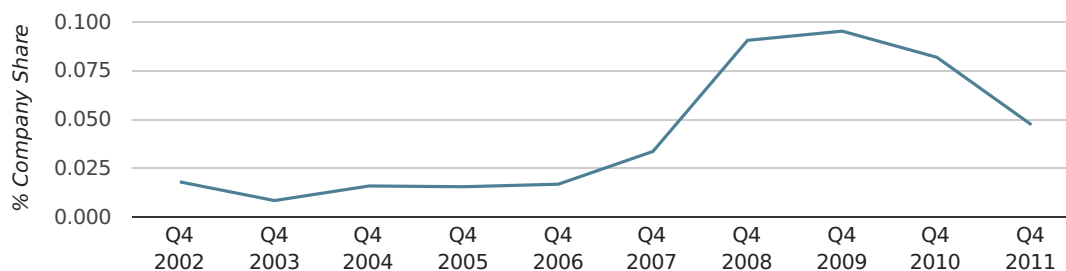

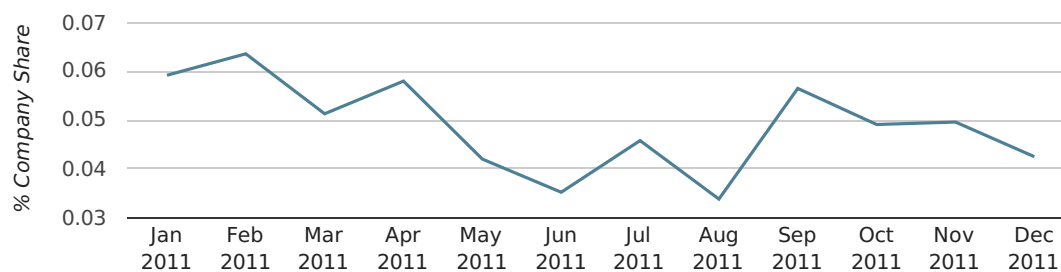

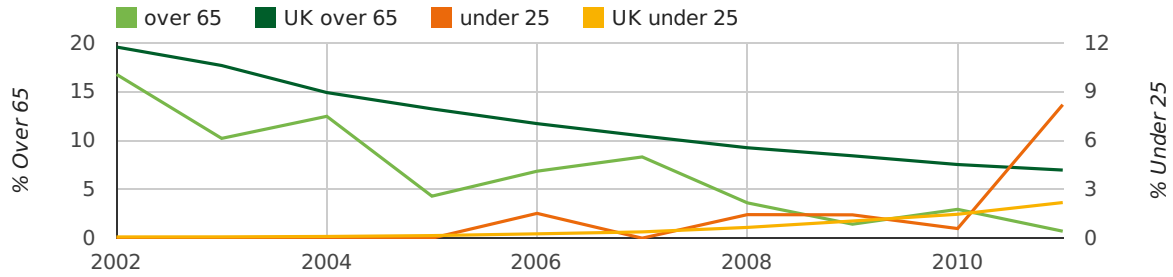

#### director age by year



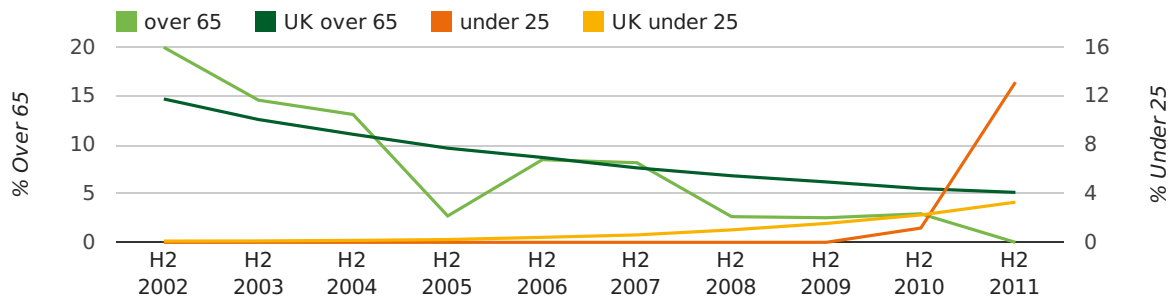

#### director age by half year



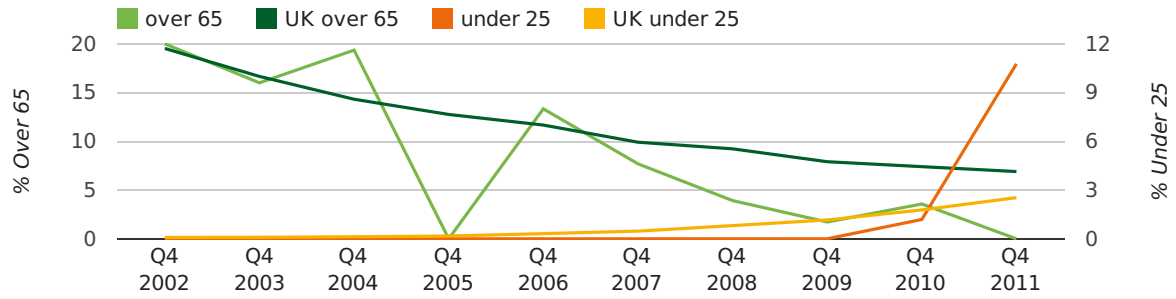

## director age by quarter

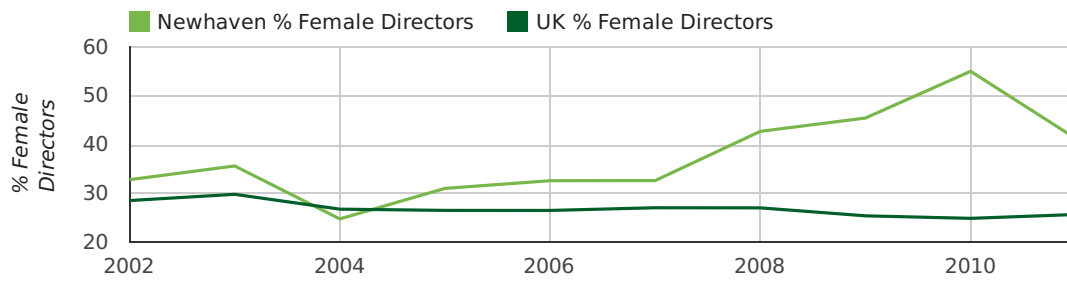


### Annual Data (2011)

### director gender by year

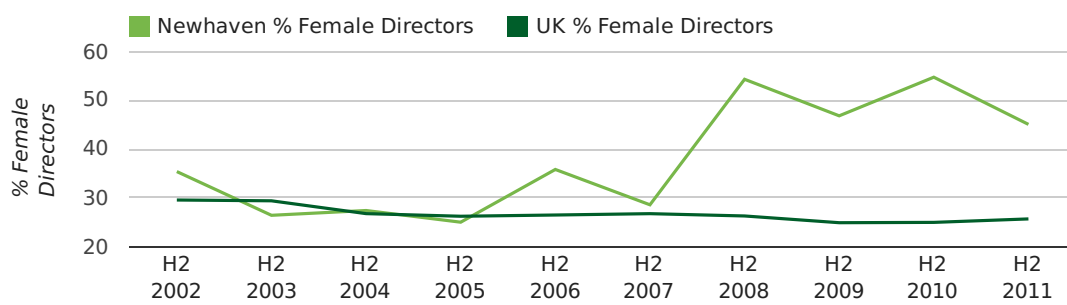


### Half Year Data (Jul-Dec 2011)

### director gender by half year

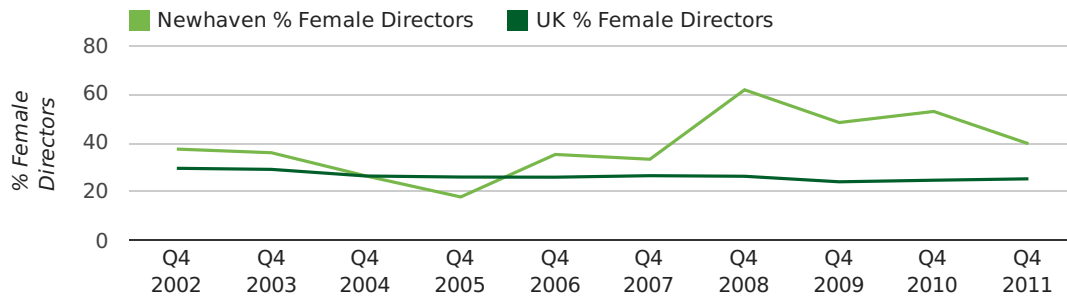


## Quarterly Data (Q4 Oct-Dec 2011)

The record fourth quarter for female directors in Newhaven was in 1977 when 31.1% of all directors were female.

39.7% of all director appointments in Newhaven in the fourth quarter of 2011 were female. This compares to a UK average of 25.3% for the same period.
