

A total of 185 companies were formed in Newmarket in 2011. This total is 12.1% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Newmarket when compared to any previous second half year.

Q4 2011 saw a new record in company registrations in Newmarket when compared to any previous Q4.


Q4 2011 was a record quarter for company registrations in Newmarket when compared to any quarter in history.





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 25 companies were dissolved in Newmarket during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


dissolved companies by quarter


A total of 77 companies were added to the company register for Newmarket in 2011. This number represents growth of 46.7% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




net growth by quarter

net growth by month






company share by half year





director age by year





director age by half year


