

Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 89 companies were formed in Newport Pagnell. This figure is 8.5% higher than last year, which compares badly to the UK wide figure of 14.0%.




new companies by half year



dissolved companies by year




Half Year Data (Jul-Dec 2011)




A total of 47 companies were dissolved in Newport Pagnell during the fourth quarter of 2011 (Oct 2011 - Dec 2011).








Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Newport Pagnell during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was -2 companies.

net growth by quarter






company share by year







director age by year




director age by half year

director gender by year




Half Year Data (Jul-Dec 2011)

26.6% of all director appointments in Newport Pagnell in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


director gender by half year
