A total of 84 companies were registered in Newton Abbot during the second quarter of 2012 (Apr 2012 - Jun 2012).







A total of 54 companies were dissolved in Newton Abbot during the second quarter of 2012 (Apr 2012 - Jun 2012).










company share by half year





director age by half year




