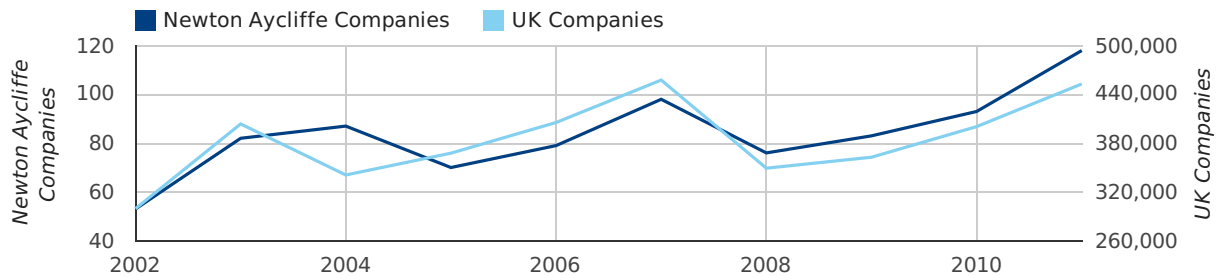
## Annual Data (2011)

2011 was a record year for company registrations in Newton Aycliffe when compared to any year in history.

A total of 118 companies were formed in Newton Aycliffe in 2011. This total is 26.9% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

The second half of 2011 saw a new record in company registrations in Newton Aycliffe when compared to any previous second half year.

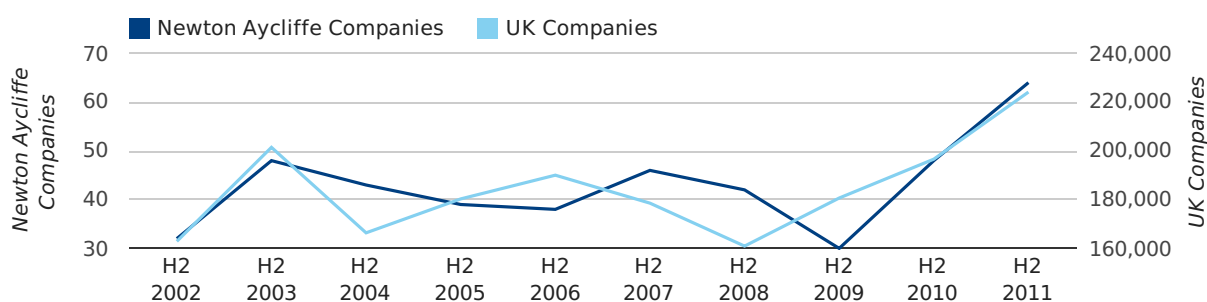
The second half of 2011 was a record second half year for company registrations in Newton Aycliffe when compared to any half year in history.

In the second half of 2011 a total of 64 companies were formed in Newton Aycliffe. This figure is 33.3% higher than last year, which compares well to the UK wide figure of 14.0%.

## Quarterly Data (Q4 Oct-Dec 2011)

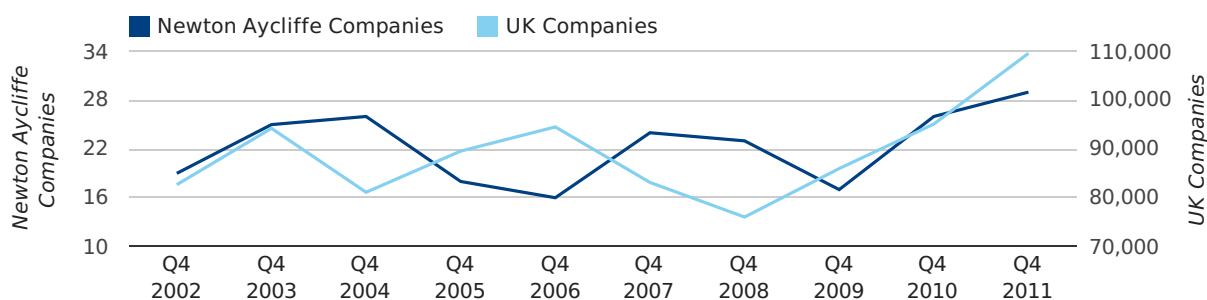
Q4 2011 saw a new record in company registrations in Newton Aycliffe when compared to any previous Q4.

A total of 29 companies were registered in Newton Aycliffe during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

This figure is an increase of 11.5% versus the same period last year (Q4 2010). This figure compares badly to the UK as a whole, which saw an increase of 15.3% against the same period last year.

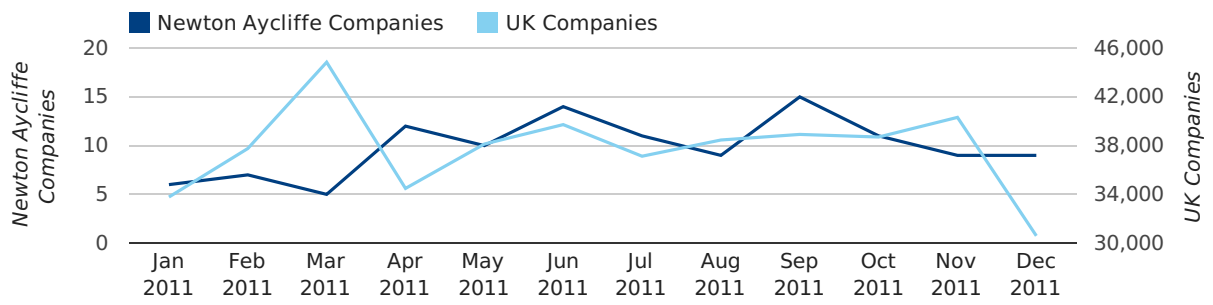

A total of 57 companies were dissolved in Newton Aycliffe in 2011. This total is 40.0% lower than in 2010 and compares unfavourably to the UK figure of 8.1% decrease compared to the previous year.

### dissolved companies by year



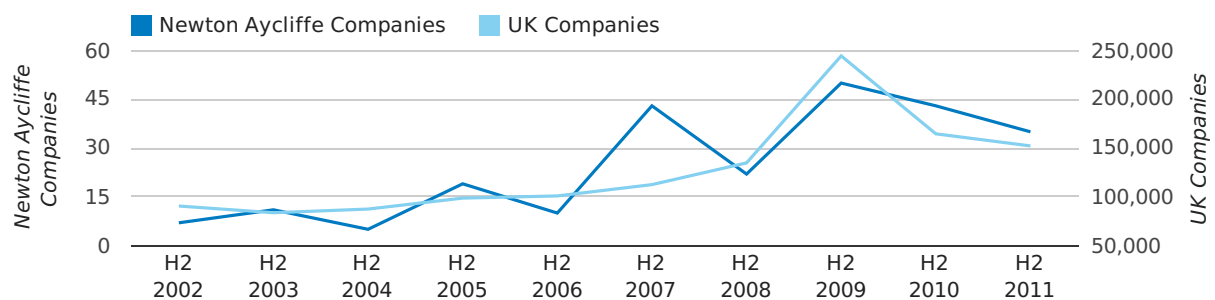
### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 35 companies were dissolved in Newton Aycliffe. This figure is 18.6% lower than last year, which compares well to the UK wide change of -7.5%.

The highest total for a second half year in Newton Aycliffe occurred in 2009 when a total of 50 were closed.

### dissolved companies by half year



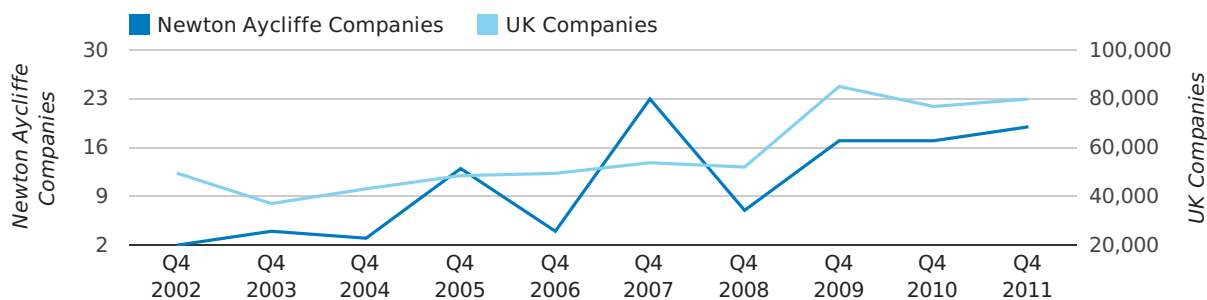
## Quarterly Data (Q4 Oct-Dec 2011)

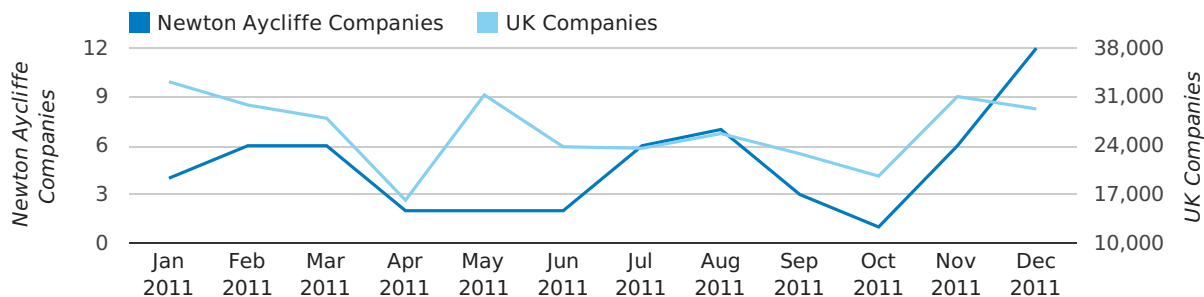
### dissolved companies by quarter

### Annual Data (2011)

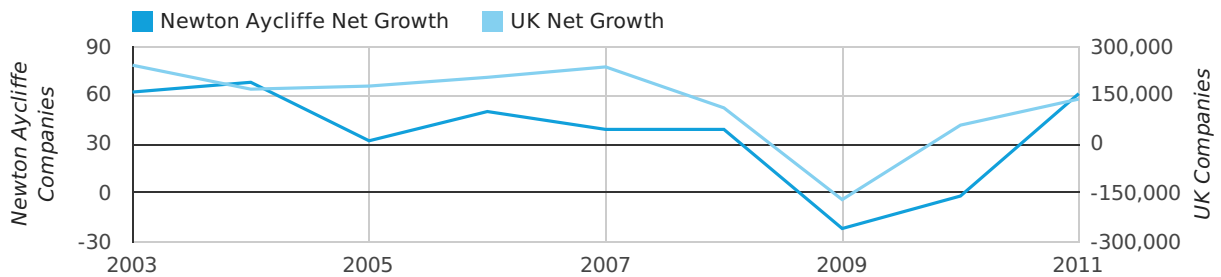

### net growth by year

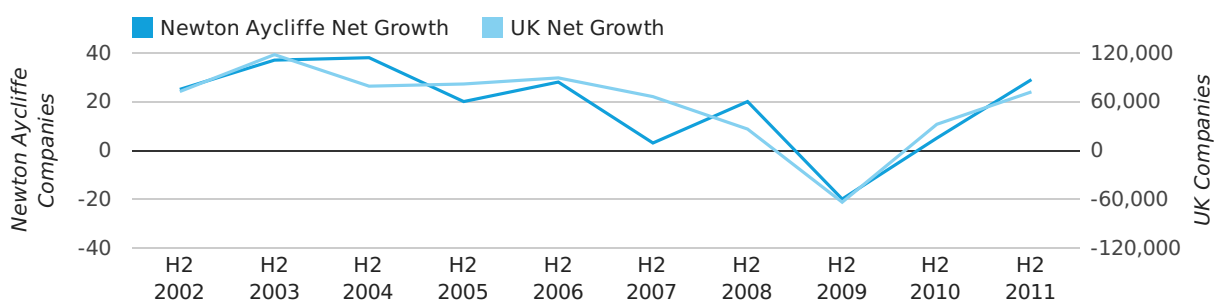


### Half Year Data (Jul-Dec 2011)

### net growth by half year





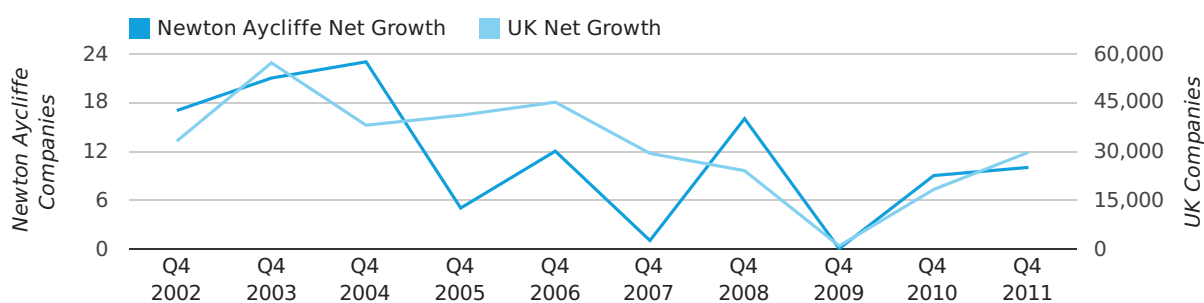
## Quarterly Data (Q4 Oct-Dec 2011)

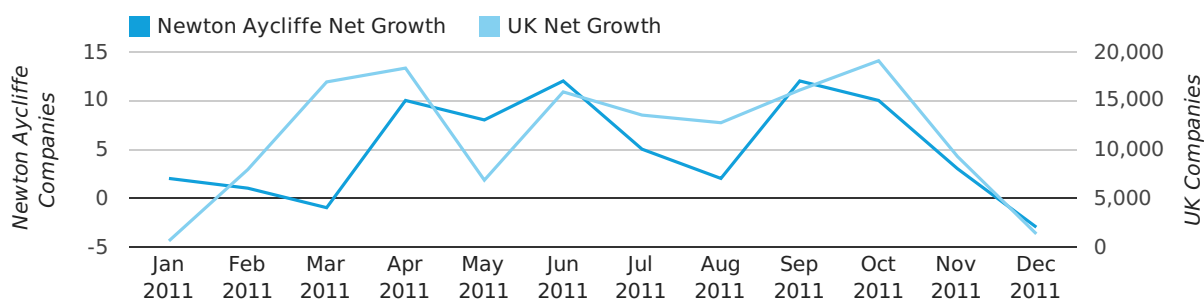
### net growth by quarter

### net growth by month



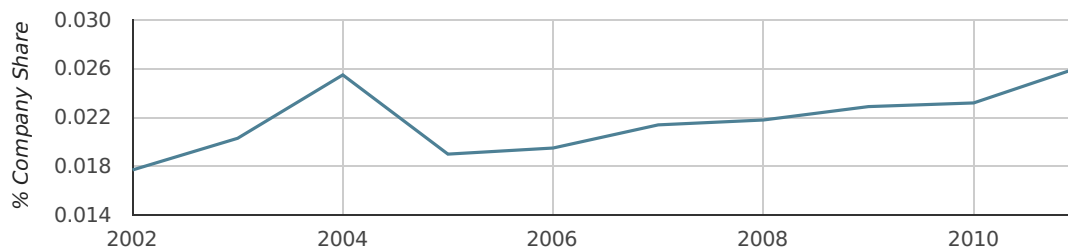

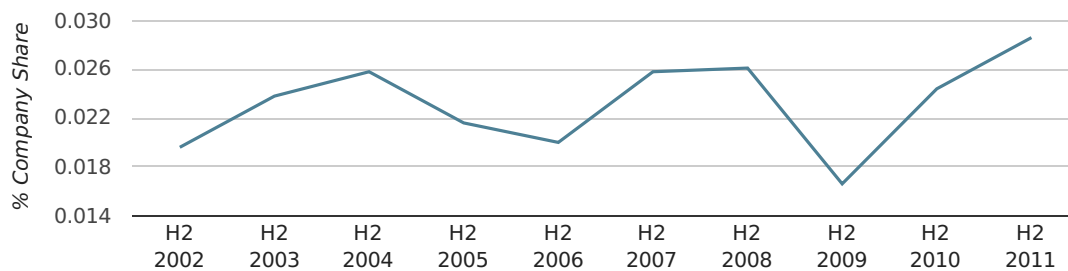

### company share by half year

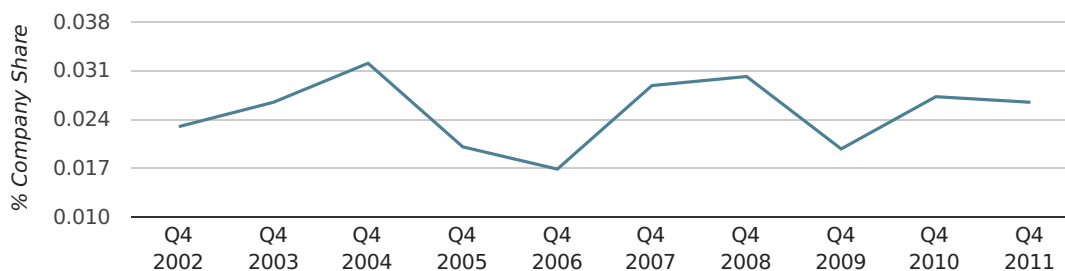

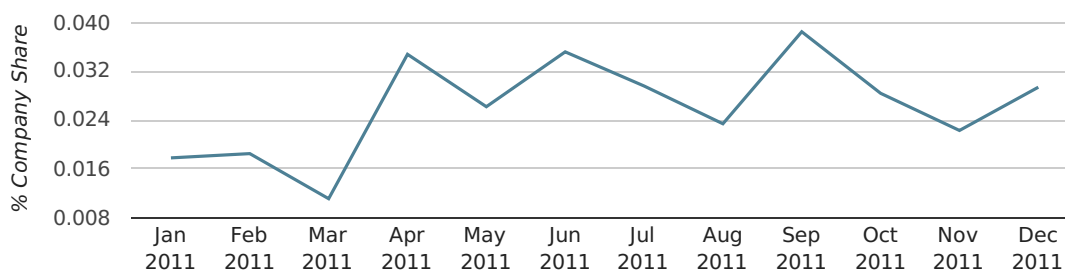

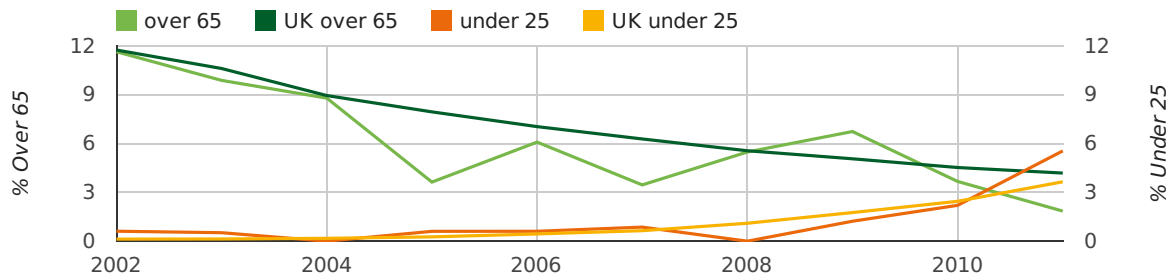

#### director age by year



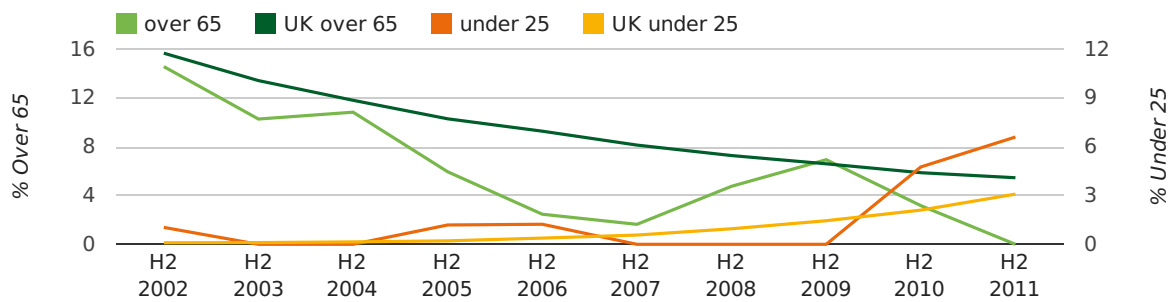

#### director age by half year



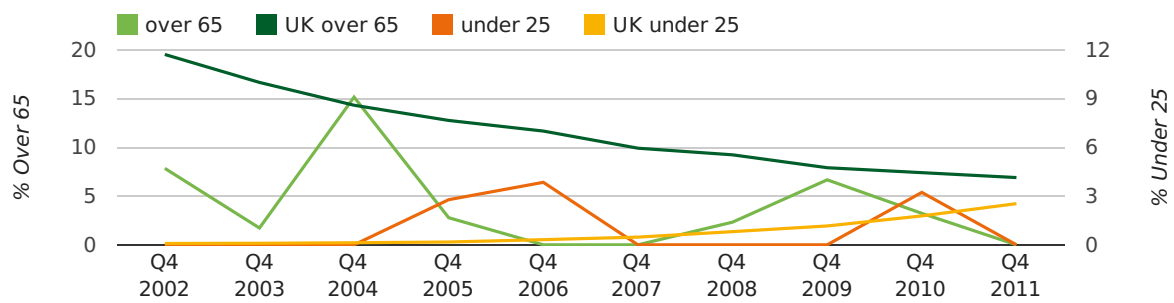

### director age by quarter

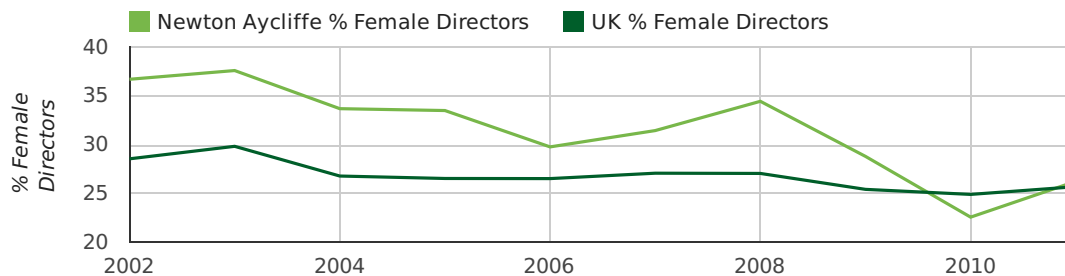


### Annual Data (2011)

#### director gender by year

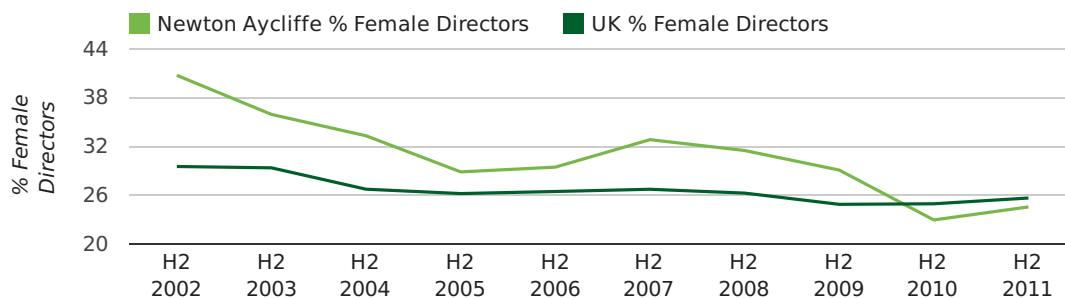


### Half Year Data (Jul-Dec 2011)

#### director gender by half year

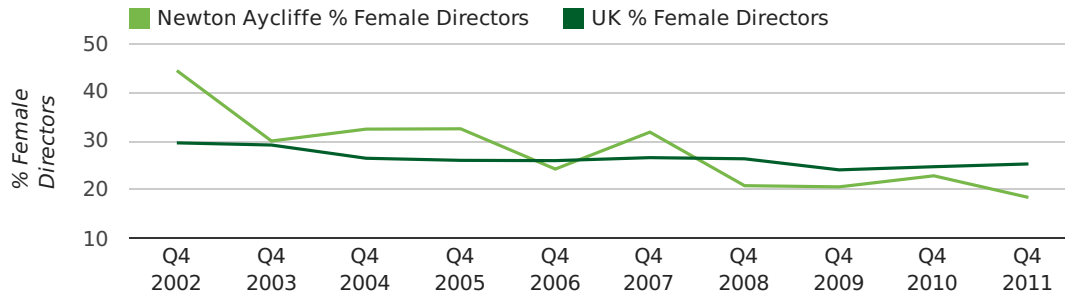


## Quarterly Data (Q4 Oct-Dec 2011)
