


The second half of 2011 saw a new record in company registrations in Newtownards when compared to any previous second half year.




A total of 37 companies were registered in Newtownards during the fourth quarter of 2011 (Oct 2011 - Dec 2011).








A total of 26 companies were dissolved in Newtownards during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


dissolved companies by quarter


A total of 44 companies were added to the company register for Newtownards in 2011. This number represents growth of 34.9% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Q4 2011 saw a new record in net growth in Newtownards when compared to any previous Q4.

net growth by quarter



net growth by month








company share by half year





director age by year





director age by half year



director gender by year


