
The first half of 2012 was a record first half year for company registrations in Norfolk when compared to any half year in history.

In the first half of 2012 a total of 1,832 companies were formed in Norfolk. This figure is 7.8% higher than last year, which compares equally to the UK wide figure of 10.7%.

The highest total for a first half year in Norfolk occurred in 2012 when a total of 1,832 were formed.

#### new companies by half year




## Quarterly Data (Q2 Apr-Jun 2012)

A total of 809 companies were registered in Norfolk during the second quarter of 2012 (Apr 2012 - Jun 2012).





#### dissolved companies by half year





A total of 515 companies were dissolved in Norfolk during the second quarter of 2012 (Apr 2012 - Jun 2012).





## net growth by half year





Net company growth for Norfolk during the second quarter of 2012 (Apr 2012 - Jun 2012) was 294 companies.











## director age by half year





The percentage of directors over the age of 65 was 4.1% compared to the UK figure of 3.3%.


#### director age by quarter
