

In the first half of 2011 a total of 916 companies were formed in Northampton. This figure is 10.9% higher than last year, which compares badly to the UK wide figure of 12.3%.

The highest total for a first half year in Northampton occurred in 2007 when a total of 1,390 were formed.

#### new companies by half year




## Quarterly Data (Q2 Apr-Jun 2011)



#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2011)

A total of 317 companies were dissolved in Northampton during the second quarter of 2011 (Apr 2011 - Jun 2011).

This figure is a decrease of 23.4% versus the same period last year (Q2 2010). This figure compares poorly to the UK as a whole, which saw a decrease of 24.9% against the same period last year.



#### net growth by half year













#### director age by half year





The percentage of directors over the age of 65 was 3.3% compared to the UK figure of 4.3%.


#### director age by quarter
