
The first half of 2011 saw a new record in company registrations in Northolt when compared to any previous first half year.




Quarterly Data (Q2 Apr-Jun 2011)

A total of 63 companies were registered in Northolt during the second quarter of 2011 (Apr 2011 - Jun 2011).





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2011)








company share by half year





director age by half year






director age by quarter
