

new companies by year




Half Year Data (Jul-Dec 2011)

new companies by half year




A total of 109 companies were registered in Northwich during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


new companies by quarter



dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 52 companies were dissolved in Northwich during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


dissolved companies by quarter


A total of 105 companies were added to the company register for Northwich in 2011. This number represents growth of 29.2% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Northwich during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 57 companies.


net growth by quarter

net growth by month






company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)

director gender by half year


