

new companies by half year




Quarterly Data (Q2 Apr-Jun 2011)

A total of 108 companies were registered in Northwood during the second quarter of 2011 (Apr 2011 - Jun 2011).



dissolved companies by half year





A total of 99 companies were dissolved in Northwood during the second quarter of 2011 (Apr 2011 - Jun 2011).





net growth by half year







company share by half year







director age by half year






director age by quarter
