




Q1 2011 saw a new record in company closures in Norwich when compared to any previous Q1.


#### dissolved companies by quarter

#### dissolved companies by month













26.3% of all director appointments in Norwich in the first quarter of 2011 were female. This compares to a UK average of 25.4% for the same period.
