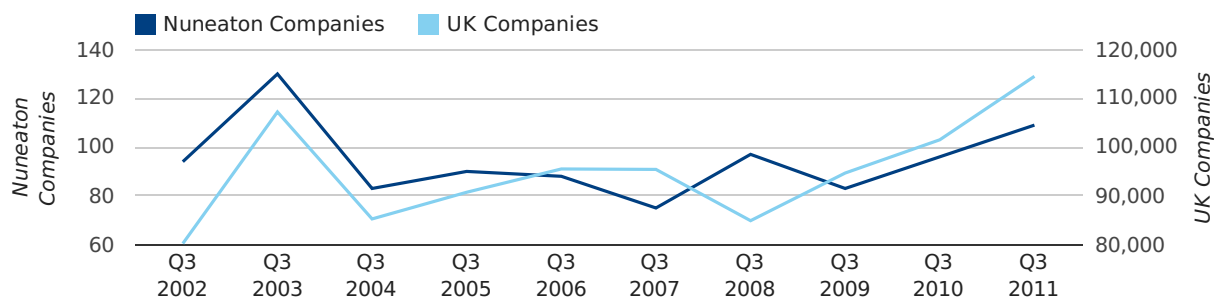
### Quarterly Data (Q3 Jul-Sep 2011)

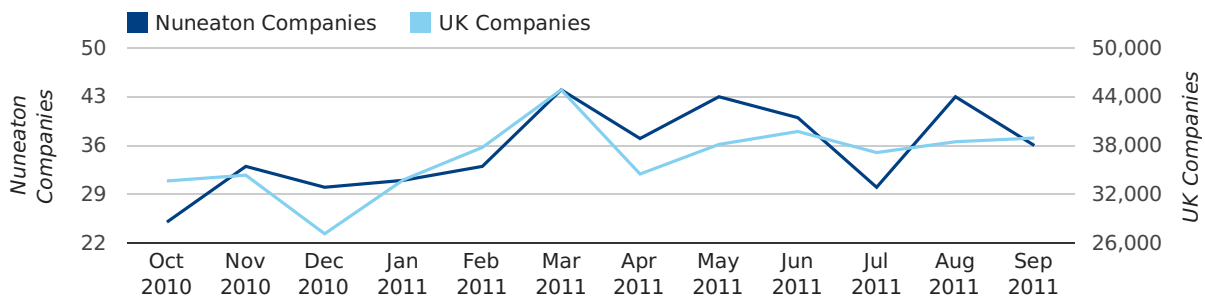

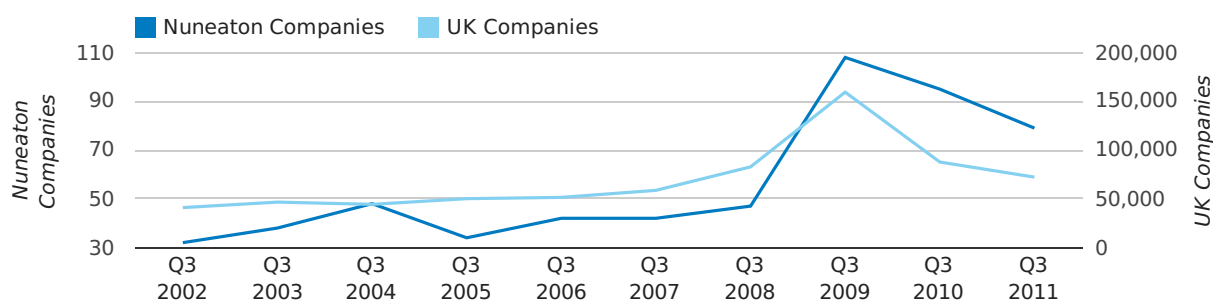
### Quarterly Data (Q3 Jul-Sep 2011)

This figure is a decrease of 16.8% versus the same period last year (Q3 2010). This figure compares poorly to the UK as a whole, which saw a decrease of 17.6% against the same period last year.

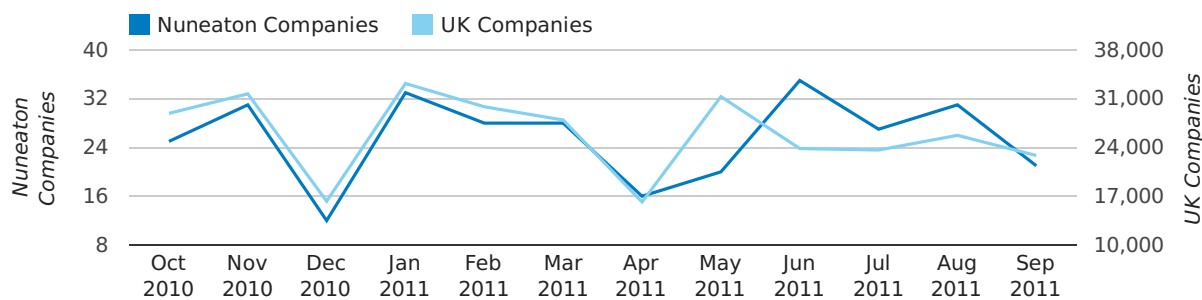

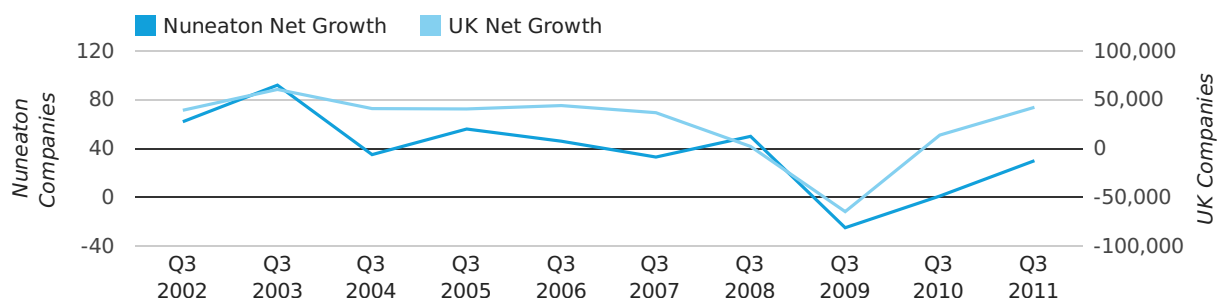

This represents an increase of 2,900.0% on the same period last year.

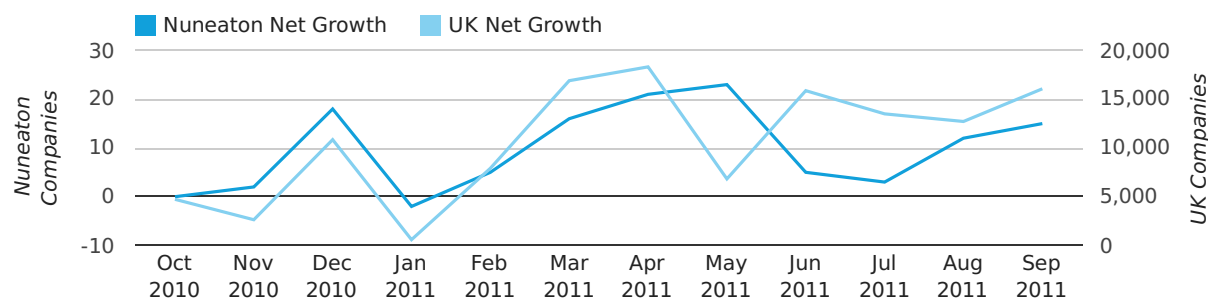

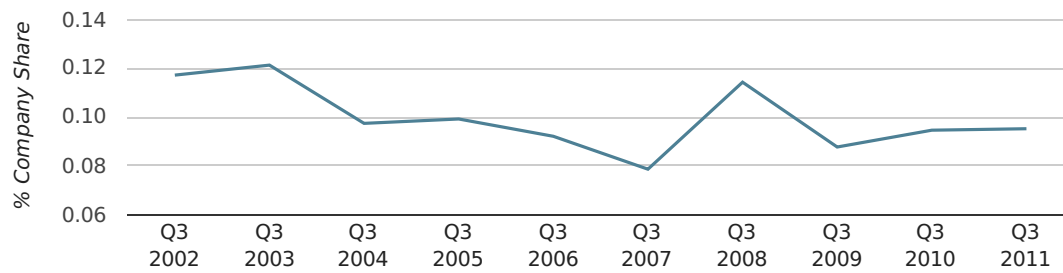

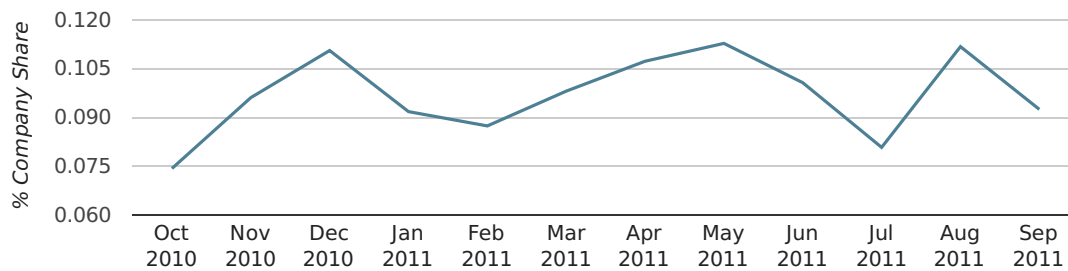

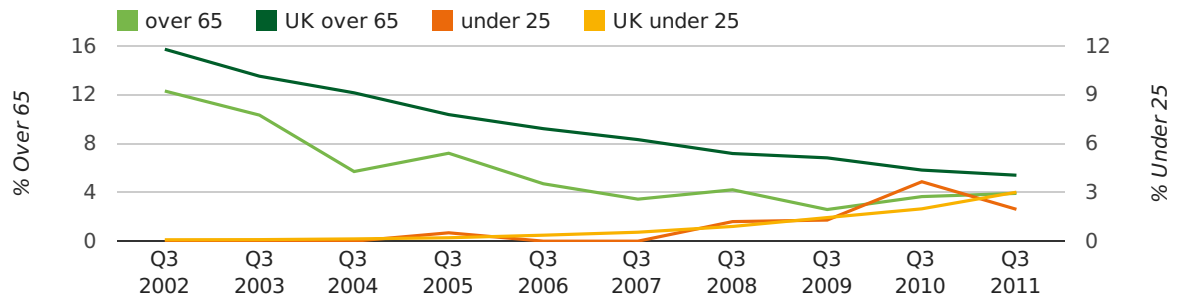
### Quarterly Data (Q3 Jul-Sep 2011)

The percentage of directors over the age of 65 was 3.9% compared to the UK figure of 4.1%.

#### director age by quarter

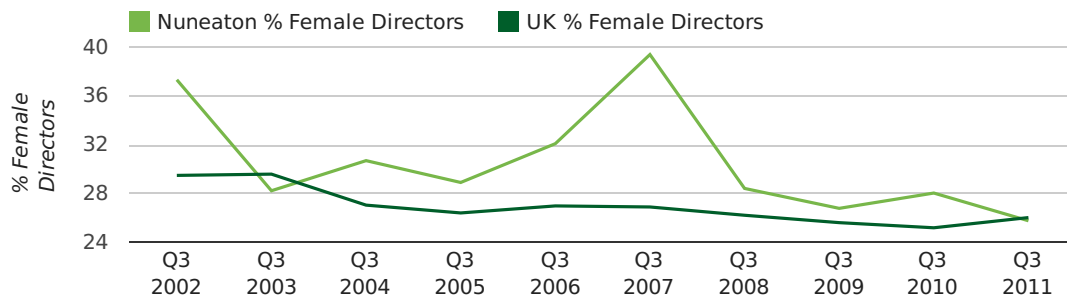


### Quarterly Data (Q3 Jul-Sep 2011)

The record third quarter for female directors in Nuneaton was in 1862 when 50.0% of all directors were female.

25.8% of all director appointments in Nuneaton in the third quarter of 2011 were female. This compares to a UK average of 26.0% for the same period.
